2. Saturdays falling on 14<sup>th</sup> January, 11<sup>th</sup> February, 11<sup>th</sup> March, 8<sup>th</sup> April, 13<sup>th</sup> May, 10<sup>th</sup> June, 8<sup>th</sup> July, 12<sup>th</sup> August, 9<sup>th</sup> September, 14<sup>th</sup> October, 11<sup>th</sup> November, 9<sup>th</sup> December will be closed Saturdays for Subordinate Court.
3. Summer Vacation of Subordinate Court shall be from 22<sup>nd</sup> May 2017 to 16<sup>th</sup> June, 2017 and Winter Vacation from 22<sup>nd</sup> December 2017 to 31<sup>st</sup> December, 2017.
4. Subordinate Courts will not observe the holidays declared or changed suddenly by the State Government/Competent Authority without approval of High Court.
5. The District Judge of the concerned district shall declare three Local holidays declared by the Collector/Commissioner of the concerned District or Tehsil without approval of the High Court under intimation to this Registry.
6. The holidays in respect of Id-ul-Fitar, Id-ul-Zuha, Moharrum and Id-milad un-Nabi are subject to change depending upon the visibility of moon.

The Saturday of every month (except Second Saturday) shall be utilized by the Subordinate Court as per the Registry Memo No. B/2380/III-6-8/85 Pt-II dt. 26-05-2010.
