2. Kindly ensure the eligibility of the candidates as per Rule 6 of the M.P. Civil Services (General Conditions of Service) Rules, 1961 by verifying the testimonials relating to the candidates' respective domicile certificate, caste certificate, certificate relating to physical handicap, certificate relating to educational qualifications, certificate relating to Stenography & Typing and Diploma in Computer Applications from an institute, recognised by the Government of M.P. and other details, wherever applicable.

3. Kindly order appointment as per the reservation roster maintained in the district.


4. Kindly get the certificates relating to Stenography/Typing verified from the institute within a period of 6 months and if any discrepancy is noticed kindly take an appropriate action, for which you are competent as Appointing and Disciplinary Authority. It would be redundant to seek any guidance etc. from the Registry in this regard.

In addition, I wish to apprise you, as directed, that the Select List and Waiting List of successful candidates will remain in force for the period of 18 months from the date of declaration of the final list and shall become invalid after declaration of the results of the following year's examination. Therefore, if any vacancy arises due to non joining of a candidate or on account of resignation/death of a candidate during the period, in which the Wait List is in force, the vacancy, thus created, would not be treated as a new vacancy and the said post will be filled by appointing a candidate from the Wait List only, for which recommendation can be sent by you to the High Court.

I would also like to mention here that merely endorsing the appointment letter to the Registry would be redundant.
