## NOTIFICATION

In exercise of the powers conferred by sub-section 3 of Section 9 of the Code of Criminal Procedure, 1973 (Act No. 2 of 1974) and all other enabling provisions, the High Court of Madhya Pradesh hereby designates the Courts of the Additional Sessions Judges, mentioned in the Column no. 3 of the following table at the places mentioned in column no. 2, for the area of jurisdiction specified in Column no. 4 thereof for trial of offences relating to **VYAPAM** scam matters and matters linked thereto, investigated by the Central Bureau of Investigation, Delhi or Special Task Force, Bhopal, in supersession of all its earlier notifications in this regard in respect of designating Courts for trial of cases relating to VYAPAM scam matters in the State.
