

In exercise of the powers conferred by section 12 of the Madhya Pradesh Civil Courts Act, 1958 (Act No. 19 of 1958), the High Court of Madhya Pradesh hereby directs that Shri Sameer Kulshreshtha, Second Additional District and Sessions Judge, Badwani, who was directed to hold sitting at Sendhwa in addition to his place of sitting for a period of 15 days in a month for holding Link Court, will hold sitting at Badwani only on all working days in a month. 
