Madhya Pradesh State Judicial Academy, High Court of M.P., Jabalpur is conducting Second Refresher Course for the Civil Judges Class II of 2012 Batch from 03.08.2015 to 07.08.2015 in the Academy. Civil Judges, whose names and postings figure in the endorsement are directed to attend the aforesaid course.

Conditions for the course:

- 1. Barring exceptional circumstances, the participants nominated for the course shall not pray for adjustment.
- 2. The participants shall report by 9.30 a.m. on 03.08.2015 in MPSJA at Jabalpur.
- 3. They shall appear for the course in prescribed uniform (i.e. Black coat, white shirt, grey trousers and black tie in the case of men and white saree and blouse with black coat in the case of ladies) during entire duration of the course.
- 4. The participants shall send one copy each of the following to the Academy sufficiently in advance i.e. latest by 20th July, 2015 and shall also bring the duplicate of the same with them while attending the Course:

- 7. T.A. & D,A. of the participants is reimbursable only as per Government Rules.
- 8. The Academy shall endeavour to make best possible arrangements for reception, lodging, boarding and entertainment of the participants in the Guest House of the Academy.
