Judicial Officers' Training & Research Institute, High Court of M.P., Jabalpur is conducting **Induction Training (THIRD PHASE)** for the newly appointed **Civil Judges of Class II of 2013 Batch** from **21.04.2014 to 16.05.2014** in the Institute. Trainee Judges, whose names and postings figure in the endorsement are directed to attend the aforesaid course.

Conditions for the course:

- 1. Barring exceptional circumstances, the participants nominated for the course shall not pray for adjustment.
- 2. The participants shall report by **9.30 a.m.** on **21.04.2014** in the Lecture Room of JOTRI at Jabalpur.
- 3. They shall appear for the course in prescribed uniform (i.e. Black coat, white shirt, grey trousers and black tie in the case of men and white saree and blouse with black coat in the case of ladies) during entire duration of the course.
- 4. The participants shall bring with them one copy each of the following, if delivered/ prepared during their Third Phase Practical Exercise:
 - (i) Judgments in Civil and Criminal cases (preferably, contested);
 - (ii) Issues;
 - (iii) Charge and
 - (iv) Examination of accused;
 - (v) The notes prepared by them during Third Phase Practical Exercise; and
 - (vi) Notes prepared by them during programmes under the aegis of District Legal Services Authority, attended/ conducted by them.
- 5. The participants may send legal problems which they want to be addressed during the course to the Institute by fax (No. 0761-2628679) sufficiently in advance.
- 6. The participants shall bring with them Laptop Computers with peripherals and software CDs, if provided by the High Court.
- 7. T.A. & D.A. of the participants is reimbursable only as per Government Rules.
- 8. The Institute shall endeavour to make best possible arrangements for reception, lodging, boarding and entertainment of the participants in the Guest House of the Institute. To this end, two Reception Counters for participants shall be set up between 5.00 a.m. and 10.00 a.m. on first day of the course at Main Railway Station, Jabalpur. One such Counter shall be set up near main exit gate of Platform No. 1 and the other near main exit gate of Platform No. 4. Participants are requested to report to these counters on their arrival. The Institute shall make arrangement for their conveyance from the Railway Station to Institute.

The participants arriving a day earlier or at hours other than those mentioned above or by a different mode of conveyance, may inform the Institute to Shri Gyan Prakash Tekam, A.G. III on Telephone No. **0761-2628679** or to Shri Pramod Kushwaha, Care Taker on Mobile No. **09713717147** or to Shri Pramod Kumar Chaturvedi, A.G. II on Mobile No. **08878747939** at least a day in advance, so that proper arrangement for their reception may be made. It may however be noted that it may not be possible for the Institute to make arrangement for carriage of participants' luggage to the parked vehicles.

- 9. The Guest House of the Institute is located on second and third floors of the JOTRI building. At present the lift is not functional. The participants are, with prior intimation to the Institute, free to stay at the accommodation of their choice. In such a case the participants shall be entitled to T.A & D.A as, per rules. However, it would not be possible for the Institute to make arrangement for pick up from and drop back to such place.
- 10. The accommodation in the Guest House of the Institute shall be available to the participants only from 3.00 p.m. onwards on the preceding day of commencement of training and upto 10.00 a.m. on the succeeding day of the end of training.
- 11. The participants shall be provided with tea, breakfast, lunch and dinner during their period of stay for the course, free of charge.
