In continuation of earlier order dated 01.04.2025, it is further directed that the information about Mentioning of the Case only for the same day shall be given to the opposite party/parties at least one day in advance through copy of Mention Memo, which will be duly acknowledged in writing by the opposite party/parties. The opposite party/parties may or may not give the consent for the Mentioning of such Case. Such Mentioning, in which consent has been given or not, will be entertained by the concerned Bench as per earlier order dated 01.04.2025.

Similarly, in order to ensure administration of justice, it is also directed that, if any party/parties seek(s) adjournment in any Case, such party/parties shall give information regarding seeking adjournment at least one day in advance through attached format, which will be duly acknowledged in writing by the opposite party/parties. The opposite party/parties may or may not give the consent for adjournment of the Case. Such request for seeking adjournment will be entertained by the respective Benches.

No Mentioning / request for adjournment will be entertained without complying the aforesaid direction.
