High Court of Madhya Pradesh hereby prescribes norms/guidelines for screening of cases of Judicial Officers on completion of 10 years of service or on attaining the 50 years of age, whichever is earlier, as per the provision laid under M.P Judicial Service (Recruitment and Conditions of Service) (as amended up to date) Rules, 1994:-

GUIDELINES FOR SCREENING

- 1. Entire service record including complaints regarding integrity during the entire service period of the Judicial Officer concerned will be seen for assessing his utility to the service.
- 2. Adverse remarks against the concerned Judicial Officer in the ACRs after his/her last promotion will be considered.
- 3. Emphasis will be given to the grades obtained by the concerned Judicial Officer during the last 05 years and if the Judicial Officer concerned has not secured during the last 05 years at least three "C", he will normally be considered as an Judicial Officer who needs to be retired in public interest.
- 4. Consideration of any comments/remarks of the High Court or the Supreme Court regarding judicial work of the concerned Judicial Officer, if any, after the last promotion.
- 5. Disposal statistics of the concerned Judicial Officer particularly during the last 5 years will be considered.
- 6. Rules/circulars laying down criteria/grounds for screening of it's employees issued by the State Government from time to time may also be taken into consideration while considering case of a Judicial Officer.
