It has been observed that Officers posted in the Madhya Pradesh State Judicial Academy (MPSJA) are sometimes making correspondence directly with the Registry and not through proper channel i.e. Director, MPSJA, which is against the normal practice. It is therefore, directed that henceforth all the Officers posted and working in MPSJA shall make all correspondence relating to the functioning of the Academy (such as notesheets, proposals, reports, letters etc.) as also in their own matters in official capacity (such as requests/prayers on the notesheets, representations, reply, letters, response, reports etc.) through proper channel i.e. through the Director, MPSJA.

It is further directed that all officials/ministerial staff posted in MPSJA shall make correspondence through the officer under whom he/she is working which, finally be processed through the Director, MPSJA.
