## //CIRCULAR//

Following instructions are issued to the Advocates, Litigants, Officers of the State Government as well as the Registry officers and employees of the High Court of Madhya Pradesh for compliance until further orders, in view of the outbreak of the Corona Virus (COVID-19):-

1. The entry of the Advocates, Clients, Officials of the State Government as well as the Officers and Employees of the High Court of Madhya Pradesh in the main building shall only be from Gate No.05.
2. The litigants shall be permitted to enter in the premises only subject to the issuance of certificate by his/her Advocate that the case has been listed on that date for hearing before the Hon'ble Court.
3. **No vehicle (either Four wheeler or Two wheeler) shall be parked inside the Court premises (Main Building) by any of the Advocate, Employee and Client.** The officers and employees of the High Court of Madhya Pradesh having office in the Administrative Block shall parked their wheelers and four wheelers in the parking space provided behind the Mazaar, whereas the officers and officials of the Main building and presentation Center shall parked their vehicles in the old District Court premises.
4. The Advocates, Clients, Officers and Employees visiting the High Court premises are requested to cooperate with the Administration to fight the possible threat of Corona Virus.

5. The persons visiting the Court premises are advised to maintain cleanliness in the Court premises, so as to avoid the possible spread of the aforesaid Virus.
