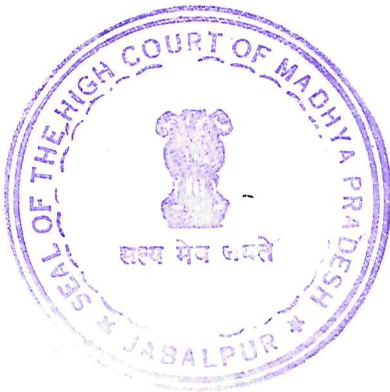
CIRCULAR

Hon'ble High Court of M.P. in Criminal Revision No. 4209/2025 (Ramlal Patel V/s State of M.P.) vide order dated 13.10.2025 has issued directions which are as under :-

1. *"That, in accordance with Rule 4,8 and 10 of the Departmental Manual, it is evident that Special Public Prosecutor(s) appointed by the Special Police Establishment (Lokayukt) before this Hon'ble Court are not permitted to appear on behalf of private party in matters related to Prevention of Corruption Act, 1988 against the Central Bureau of Investigation or State Government."*
2. *"None of the counsels appearing for CBI will be entitled to appear against the State Lokayukt or the EOW in the matters under the Prevention of Corruption Act."*

Copy of order dated 13.10.2025 passed in Criminal Revision No. 4209/2025 (Ramlal Patel V/s State of M.P.) is attached herewith for strict compliance.

Circular shall come into force with immediate effect.

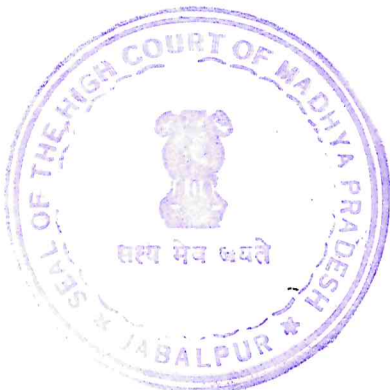

ORDER

Per. Justice Vivek Agarwal

In compliance of the order dated 11.09.2025 passed by this Court, affidavit of Shri Jagroop Samarthlal Gusinha S/o Shri Samarth Lal Meena, Joint Director, Central Bureau of Investigation, Bhopal Zone has been filed.

Affidavit filed vide I.A. No.6734/2025 is taken on record in which in para 3, 4 and 5 it is mentioned as under :-

"3. That OM F. No. 26(1)/99-Judl. Dated 24.09.1999 issued by Department of Legal Affairs, Ministry of Law, Government of India provides guideline that a Counsel shall not advise any party in or accept any case against the Government of India in which he has appeared or is likely to be called upon to appear for or advise or which is likely to affect or lead to litigation against the Government of India (Annexure A).





4. However, there are no specific guidelines either from CBI or DoLaw.r.t state agencies and state anti-corruption cases for the Central Government Standing Counsel. It is silent on appearance against State Agencies.

5. That, although there is no express bar exists, as a general principle and on grounds of professional ethics, a Retainer Counsel/Spl. PP of CBI ought to refrain/desist from appearing against the CBI, and by implication, also against the State Lokayukt in matters under the Prevention of Corruption Act."

In this behalf affidavit of Shri Yogesh Deshmukh, Director General (Special Police Establishment), Lokayukt is also taken on record and has noted in para 4 as under ;-

"4. That, in accordance with Rule 4, 8 and 10 of the Departmental Manual, it is evident that Special Public Prosecutor(s) appointed by the Special Police Establishment (Lokayukt) before this Hon'ble Court are not permitted to appear on behalf of private party in matters related to Prevention of Corruption Act, 1988 against the Central Bureau of Investigation or State Government."

In view of such facts, let a circular be issued by the Registry that none of the counsels appearing for CBI will be entitled to appear against the State Lokayukt or the EOW in the matters under the Prevention of Corruption Act.

Learned counsel for the applicant prays for withdrawal of this revision
