



HIGH COURT OF MADHYA PRADESH SERVICES (RECRUITMENT,  
GENERAL CONDITIONS OF SERVICES, CONDUCT, CLASSIFICATION,  
CONTROL AND APPEAL) RULES, 2017

1. In clause (k) of Rule 2, after the words "means the", the words "Accounts Officer" shall be substituted by the words "Deputy Controller Accounts".
2. In clause (e) of Rule 2, after the words "means the", the words "Budget Officer" shall be substituted by the words "Controller Accounts".
3. In clause (x) of Rule 2, at the end, the words "or equivalent" shall be substituted by the words "and Chief Librarian".

4. In sub-rule (2) of Rule 16, in the first para;
  - (i) The words "Chief Justice or such Puisne" shall be substituted by the words "High Court".
  - (ii) Between the words "Committee of" and "Judges", the words "High Court" shall be added.
5. In sub-rule (2) of Rule 17;
  - (i) The words "Chief Justice" shall be substituted by the words "High Court Judge or the committee of High Court Judges".
  - (ii) The words "a committee of three senior most Judges" shall be substituted by the words "the Chief Justice".
6. In the schedule-I, at serial No.01;
  - (i) In column No.9, the words "by promotion from amongst Principal Registrars or .....Higher Judicial Service" shall be substituted by the following words;  
"On deputation of Judicial Officer of Super Time Scale from the cadre of the Higher Judicial Service".
  - (ii) In column No.10, the words "Principal Registrars or" shall be deleted.
  - (iii) Between the words "Judicial Officers" and "from the cadre" the words "of Super Time Scale" shall be added.
7. In the schedule I, at serial No. 15;
  - (i) In column No.09, between the words "Joint Registrars (M)" and "who have", the symbol & words "/Controller Accounts" shall be added.
  - (ii) In column No.10, after the words "Joint Registrar (M)", the symbol and words "/Controller Accounts" shall be added.
8. In the schedule-I, at serial No. 30, in column No.9 (ii);
  - (i) Between the words "filled by" and "Junior Judicial Assistant", the words and symbol "Judicial Assistant /" shall be added.
  - (ii) At the end, after the figure and words "5 years service", the words "as Junior Judicial Assistant" shall be added.
9. In the schedule-I; at serial No. 47;
  - (i) In column No.09, in the beginning, before the words "by promotion", the words "On deputation having requisite qualification. or" shall be added.
10. In the schedule-I, at serial No. 65, in Column No.6;
  - (i) Point No. (vi) shall be deleted.
  - (ii) Point No. "(vii)" shall be renumbered as point No. "(vi)".
