AHLUWALIA.THE MATTER WAS DIRECTED TO BE PLACED BEFORE HON'BLE THEACTING CHIEF JUSTICE WITH FOLLOWING OBSERVATIONS: "THE AFORESAID JUDGMENT HAS BEEN FOLLOWED AND RELIED UPON BY THE SUPREME COURT IN THE CASE OFUNION OF INDIA VS. PRAKASH.P.HINDUJA AND ANOTHER, AIR 2003 SC 2612. THUS, IT IS CLEAR THAT ONCETHE CHARGE-SHEET IS FILED, MERELY BECAUSE THE INVESTIGATING AGENCY HAD NO JURISDICTION TO INVESTIGATE THE MATTER, THE CHARGE-SHEET CANNOTBE QUASHED AS IT IS NOT POSSIBLE TO SAY THAT "COGNIZANCE ON AN INVALID POLICE REPORT IS PROHIBITED AND, IS, THEREFORE, A NULLITY."IN VIEW OF THE AFORESAID DISCUSSION, WE RESPECTFULLY DIFFER FROM THE ORDER RENDERED BY THE COORDINATE BENCH OF THIS COURT IN M.CR.C.NO.9915/2015. WE, THEREFORE, DIRECT THE REGISTRY TO PLACE THE PAPERS BEFORE HON'BLE THE ACTING CHIEF JUSTICE FOR NECESSARY ORDERS TORESOLVE THE CONTROVERSY." .....AFORESAID DIRECTIONS WERE MADE BY THE DIVISION BENCH IN VIEW OF THE EARLIER JUDGMENT PASSED BY ANOTHER DIVISION BENCH COMPRISING HON'BLE SHRI JUSTICE S.K. GANGELE AND HON'BLE SHRI JUSTICE ASHOK KUMAR JOSHI IN M.CR.C.NO.9915/2015,WHEREBY THE FINAL REPORT UNDER SECTION 173(2) OF THE CR.P.C. IN CRIME NO.47/2015 REGISTERED BY P.S.-HARDA, DISTRICT-HARDA AND THE CRIMINAL PROCEEDINGS ARISING THEREFROM WERE QUASHED HOLDING AS FOLLOWS:"IN THIS VIEW OF THE MATTER, THE INVESTIGATION CONDUCTED BY THE LOCAL POLICE AND THE CHARGE-SHEET FILED BY THE POLICE AGAINST THEPETITIONER IS WITHOUT POWER AND AUTHORITY IN REGARD TO SPECIAL OFFENCES I.E. PUNISHABLE UNDER THE PREVENTION OF CORRUPTION ACT 1988,BECAUSETHE MATTER IS INTERRELATED HENCE, IT WOULD NOT BE APPROPRIATE THAT LOCAL POLICE MAY PROSECUTE THE PETITIONER FOR OTHER OFFENCES ALSO. CONSEQUENTLY, THE CHARGE-SHEET AND THE CRIMINAL PROCEEDINGSINITIATED AGAINST THE PETITIONER VIDE CRIME NO.47/2015 REGISTERED AT POLICE STATION HARDA ARE HEREBY QUASHED BEING WITHOUT JURISDICTION. IT ISHEREBY CLARIFIED THAT THIS COURT HAS NOT OPINED ON THE MERITS OF THE CASE AND THE COMPETENCE OF COMPETENT PROSECUTING AGENCY."
