

2. PERIOD OF CONTRACT:

THE CONTRACT WILL BE INITIALLY FOR A PERIOD OF **01 YEAR** FROM THE DATE OF AGREEMENT, WHICH CAN BE FURTHER EXTENDED ON THE BASIS OF MUTUAL AGREEMENT SUBJECT TO THE SATISFACTORY PERFORMANCE OF THE DUTIES BY THE CONTRACTOR AND THE PRICE TREND OF THE SERVICES/ PRODUCTS PREVAILING IN THE MARKET ON THE DATE OF EXTENSION. THE AGREEMENT SHALL BE SUBJECT TO SCRUTINY BY THE FIRST PARTY FROM TIME TO TIME AND IF THE SERVICES RENDERED BY THE SECOND PARTY IS NOT FOUND SATISFACTORY, THE FIRST PARTY SHALL BE AT LIBERTY TO PENALISE THE SECOND PARTY AS PER TERMS OF THE AGREEMENT AND / OR TO TERMINATE THE AGREEMENT AT HIS WILL.

3. SCOPE OF WORK:

1. THE PLACE OF PERFORMANCE WILL BE THE DISTRICT COURT PREMISES, VIDISHA, TEHSEEL COURT GANJBASODA , SIRONJ, KURWAI, LATERI DISTRICT VIDISHA (M.P.). THE TENDER RELATES TO THE MECHANIZED CLEANING SERVICE AND MAINTENANCE OF GARDEN, INDOOR PLANTS, PATHWAYS, PARKING AREAS AND LIFTMEN SERVICES FOR BLOCK A, B AND C AND PUBLIC UTILITY CENTRE OF THE DISTRICT COURT BUILDING VIDISHA TEHSEEL COURT GANJBASODA , SIRONJ, KURWAI, LATERI DISTRICT VIDISHA (M.P.) .
2. IT SHALL BE THE DUTY OF THE CONTRACTOR / SERVICE PROVIDER TO HAVE THE CREDENTIALS OF THE SERVICE PERSONS/OPERATORS DULY VERIFIED AND CERTIFIED. THE PERSON ENGAGED IN MECHANIZED CLEANING SERVICE AND MAINTENANCE OF GARDEN, INDOOR PLANTS, PATHWAYS, PARKING AREAS AND

LIFTMEN SERVICES SHALL WEAR CLEAN AND PROPER DRESS AND PHOTO ID WHICH SHALL BE PROVIDED BY THE CONTRACTOR /SERVICE PROVIDER.

3. ADEQUATE NUMBER OF MACHINES WITH QUALIFIED OPERATORS SHALL BE DEPLOYED FOR MOTORISED CLEANING. FOR THE PLACES WHERE MOTORISED CLEANING IS NOT FEASIBLE ADEQUATE NUMBER OF CLEANER AND SERVICE STAFF SHALL BE DEPLOYED BY THE CONTRACTOR/SERVICE PROVIDER FOR MAINTENANCE, BEAUTIFICATION OF PREMISES. ALONG WITH THE TENDER, THE BIDDER SHALL ALSO SUBMIT THE LIST OF SERVICE PERSONS WHO WILL BE ENGAGED FOR MECHANIZED CLEANING SERVICE AND MAINTENANCE OF GARDEN, INDOOR PLANTS, PATHWAYS, PARKING AREAS AND LIFTMEN SERVICES. TO ENSURE THEIR PRESENCE AT WORK PLACE, THE CONTRACTOR SHALL MAINTAIN A REGISTER THAT WILL BE KEPT IN THE OFFICE OF THE FIRST PARTY OR WITH THE PERSON AUTHORIZED BY HIM FOR PROPER SCRUTINY.
4. THE VENDOR SHALL PROVIDE ADEQUATELY TRAINED SUPERVISOR/SUPERVISORS TO ENSURE PROPER MAINTENANCE AND MANAGEMENT OF THE MANPOWER AND MACHINES.
5. THE VENDOR SHALL ARRANGE WET AND DRY CLEANING OF ALL THE CORRIDORS, PUBLIC TOILETS, URINALS, PORCH, BASEMENT, AND OPEN AREAS TWICE A DAY AND PRIVATE TOILETS ONCE EVERYDAY.
6. THE MAINTENANCE OF GARDEN SHALL INCLUDE MAINTENANCE OF FLOWER BEDS, GRASS, PLANTS AND FLOWER POTS ALREADY EXISTING IN THE DISTRICT COURT PREMISES VIDISHA TEHSEEL COURT GANJBASODA, SIRONJ, KURWAI, LATERI DISTRICT VIDISHA (M.P.). IT SHALL ALSO INCLUDE MAINTENANCE OF ALL THE INDOOR AND OUTDOOR PLANTS WITHIN THE PREMISES. THE VENDOR SHALL ENSURE PROPER WATERING OF PLANTS ON A DAILY BASIS AND SHALL ALSO ENSURE PROPER AVAILABILITY OF THE SEASONAL FLOWERING PLANTS, MANURE, PESTICIDES, AND FERTILIZERS. IT SHALL ALSO INCLUDE MAINTENANCE OF WATER FOUNTAIN.
7. THE MAINTENANCE OF PUBLIC UTILITY CENTER SHALL INCLUDE CLEANING OF ALL THE TOILETS AND ENSURING THE AVAILABILITY OF HAND WASH LIQUIDS, AIR FRESHENERS AND DISINFECTANTS ON REGULAR INTERVALS THROUGHOUT ALL THE WORKING DAYS. THE PUBLIC UTILITY CENTER SHALL ALSO INCLUDE THE STORAGE ROOMS.

8. THE VENDOR SHALL DEPUTE ONE SWEEPER/ CLEANER AT EVERY SET OF GENTS' AND LADIES' PUBLIC TOILETS AND TWO SWEEPERS/ CLEANERS AT THE PUBLIC UTILITY CENTER THROUGH OUT THE WORKING HOURS ON ALL WORKING DAYS AND AS AND WHEN DIRECTED. THESE SWEEPERS/ CLEANERS SHALL ENSURE REGULAR CLEANING AND SANITISATION OF PUBLIC TOILETS.
9. THE VENDOR SHALL ALSO ENSURE PROPER AVAILABILITY OF HAND WASH LIQUID SOAPS AND DISINFECTANT MATS/BALLS OF GOOD QUALITY THROUGHOUT THE TOILETS IN THE BUILDING.
10. ANY OTHER WORK OF SIMILAR NATURE AS AND WHEN ASSIGNED BY THE PRINCIPAL DISTRICT AND SESSIONS JUDGE, VIDISHA SHALL BE CARRIED OUT BY THE CONTRACTOR.

4. TERMS AND CONDITIONS:

1. THE REQUIRED NUMBER OF MOTORISED CLEANING MACHINES, NECESSARY EQUIPMENTS AND MANPOWER SHALL BE PROVIDED BY THE VENDOR.
2. THE MACHINES SHALL BE OWNED, MAINTAINED AND OPERATED BY THE CONTRACTOR. THE DETAILS OF THE MACHINES, WHICH WILL BE INSTALLED SHOULD BE MENTIONED IN THE TENDER.
3. COST OF CLEANING MATERIAL AND OTHER CONSUMABLES LIKE SOAP, PHENYL, TOILET CLEANERS, BRUSH, UTENSILS, FLOOR WIPER, MUTATIS MUTANDIS SHALL BE BORNE BY THE CONTRACTOR. CLEANING MATERIAL OF REPUTED BRAND ONLY SHALL BE USED AT ALL TIMES AND IF ANY OF THE MATERIAL IS NOT FOUND OF APPROPRIATE QUALITY, THE FIRST PARTY MAY CHOOSE THE PRODUCT OF PROPER QUALITY AND THE SECOND PARTY SHALL SUPPLY ONLY THOSE ITEMS.
4. THE MACHINES SHALL BE KEPT IN SERVICEABLE CONDITION BY THE CONTRACTOR AND ITS QUALITY SHALL BE MAINTAINED.
5. THE CLEANING WORK OF ANY PARTICULAR DAY SHALL, UNDER ALL CIRCUMSTANCES, BE FINISHED BY THE CONTRACTOR ON THE SAME DAY. IF THE WORK IS NOT FINISHED ON THE SAME DAY, A PENALTY OF RS. 10,000/- PER DAY SHALL BE LEVIABLE AND SHALL BE DEDUCTED FROM THE AMOUNT PAYABLE TO THE CONTRACTOR.
6. THE CONTRACTOR OR AUTHORIZED PERSON SHALL REPORT IMMEDIATELY WHENEVER CALLED BY THE PRINCIPAL DISTRICT JUDGE OR ANY PERSON

AUTHORIZED BY HIM ON RECEIVING ANY MESSAGE TO ATTEND THE COMPLAINTS WITH REGARD TO THE CLEANING WORK/ SERVICES UNDER THE TENDER.

7. SUFFICIENT STOCK OF CONSUMABLES LIKE PHEYNYL, BRUSH, UTENSILS, FLOOR WIPER, ETC. FOR A MONTH IN ADVANCE SHOULD BE MAINTAINED IN THE ASSIGNED STORE ROOM OF THE DISTRICT COURT BUILDING. THE SECURITY AND SAFETY OF THE MACHINES AND CONSUMEABLES SHALL BE THE SOLE RESPONSIBILITY OF THE CONTRACTOR. HE SHALL BE RESPONSIBLE FOR IMMEDIATE ALTERNATE ARRANGEMENT, IF ANY MACHINE OR EQUIPMENT IS FOUND UNSERVICEABLE DUE TO ANY REASON.
8. CONTRACT SHALL BE VALID FOR A PERIOD OF **ONE YEAR** FROM THE DATE OF AGREEMENT WHICH CAN BE EXTENDED IF THE PERFORMANCE IS FOUND SATISFACTORY.
9. THE VENDOR SHALL ENSURE THAT THE ASSIGNED WORK SHALL START WITHIN 15 DAYS OF THE RECEIPT OF WORK ORDER.
10. THE MACHINE SHALL BE OPERATED ONLY BY THE OPERATOR(S) IN PROPER UNIFORM HAVING PROPER IDENTITY CARDS WHICH SHALL BE PROVIDED BY THE VENDOR TO MAN POWER.
11. THE QUOTATION WILL BE OPENED IN THE OFFICE OF THE PRINCIPAL DISTRICT JUDGE, DISTRICT COURT, VIDISHA AT **DATED 23-09-2025 AT 03:00 PM**. ONE REPRESENTATIVE OF THE BIDDER MAY REMAIN PRESENT AT THE TIME OF OPENING OF THE BID. TENDER WILL BE FINALISED AFTER CONSIDERING ALL THE PROPOSALS. ALL TENDERERS OR ANY OF THE TENDERER MAY BE CALLED FOR FURTHER NEGOTIATIONS BEFORE CONSIDERING HIS/THEIR PROPOSAL.
12. THE APPLICANT IS REQUIRED TO SUBMIT BROCHURE(S) OF THE MACHINE(S) AND LIST OF MACHINES PROPOSED TO BE INSTALLED FOR MECHANIZED CLEANING SERVICES.
13. THE PRINCIPAL DISTRICT JUDGE, VIDISHA HAS THE RIGHT OF ACCEPTING OR REJECTING ANY OR ALL TENDERS WITHOUT SPECIFYING ANY REASON(S) THEREOF. THE PRINCIPAL DISTRICT JUDGE, VIDISHA IS UNDER NO OBLIGATION TO ACCEPT THE LOWEST TENDER.
14. THERE IS NO OBLIGATION ON THE PART OF THE PRINCIPAL DISTRICT JUDGE, VIDISHA TO INFORM THE UNSUCCESSFUL TENDERER OF THE OUTCOME OF THE TENDER PROCESS AND REASONS FOR REJECTION OF THE TENDER.

15. THE SUCCESSFUL CONTRACTOR SHALL FORTHWITH ENGAGE/DEPUTE SERVICE PERSONS/OPERATORS, MACHINES AND REQUISITE MATERIALS TO PROVIDE THE DESIRED SERVICES IN THE DISTRICT COURT PREMISES, VIDISHA TEHSEEL COURT GANJBASODA , SIRONJ, KURWAI, LATERI DISTRICT VIDISHA (M.P.)
16. UNDER NO CIRCUMSTANCES, SHALL THE SUCCESSFUL FIRM APPOINT ANY SUB-CONTRACTOR OR SUB-LEASE THE CONTRACT. IF IT IS FOUND THAT THE CONTRACTOR HAS VIOLATED THESE CONDITIONS, THE CONTRACT WILL BE TERMINATED FORTHWITH WITHOUT ANY NOTICE, BY THE AUTHORITY WHO HAS APPROVED THE AWARD OF THE CONTRACT.
17. THE SUCCESSFUL TENDERER WILL BE REQUIRED TO FURNISH SECURITY DEPOSIT AMOUNTING TO RS. **10,00,000/-** WITHIN 10 (TEN) DAYS FROM THE DATE OF ACCEPTANCE OF TENDER. THE SECURITY DEPOSIT SHALL BE IN THE FORM OF FDR THROUGH ANY NATIONALIZED BANK IN FAVOUR OF THE PRINCIPAL DISTRICT JUDGE, VIDISHA OR UNCONDITIONAL BANK GUARANTEE OF ANY NATIONALIZED BANK OF EQUAL AMOUNT. THE SECURITY DEPOSIT MONEY WILL BE REFUNDABLE ONLY AFTER THE EXPIRY/TERMINATION OF THE CONTRACT.
18. THE BILLS IN TRIPLICATE FOR THE SERVICES SHALL BE PREPARED ON THE BASIS OF APPROVED RATES AND WILL HAVE TO BE SUBMITTED IN FAVOUR OF THE PRINCIPAL DISTRICT JUDGE, VIDISHA FOR EFFECTING PAYMENT. NO ADVANCE PAYMENT SHALL BE MADE FOR THE SERVICES. THE PAYMENT SHALL BE MADE SUBJECT TO AVAILABILITY OF THE FUNDS AND NO INTEREST SHALL BE PAYABLE FOR DELAY IN PAYMENT OF BILLS FOR ANY REASON, WHATSOEVER.
19. PREMATURE WITHDRAWAL OF THE TENDER BY THE TENDERER SHALL MAKE HIM LIABLE FOR FORFEITURE OF THE EARNEST MONEY AND THE SECURITY DEPOSIT.
20. ALL THE PAGES OF THE TENDER DOCUMENT SHOULD BE SERIALY NUMBERED AND DULY STAMPED AND SIGNED BY THE BIDDER.
21. THE PRINCIPAL DISTRICT JUDGE, VIDISHA RESERVES THE RIGHT TO REVIEW THE PERFORMANCE WHENEVER HE SO DESIRES, AND HE CAN ALSO GIVE NOTICE AT ANY POINT OF TIME DURING THE TENURE OF THE CONTRACT IN CASE THE PERFORMANCE AND THE SERVICES RENDERED BY THE CONTRACT FIRM IS FOUND TO BE UNSATISFACTORY.
22. THE CONTRACTOR SHOULD BE REGISTERED WITH GST, ESIC, EPF. CERTIFIED COPY OF REGISTRATION CERTIFICATES SHOWING THE CODE ALLOTTED FROM THESE ORGANIZATIONS SHOULD BE SUBMITTED ALONG WITH THE TECHNICAL BID.

23. THE CONTRACTOR SHALL BE SOLELY RESPONSIBLE FOR SAFETY OF HIS WORKMAN WHILE ON THE JOB. THE DISTRICT COURT SHALL NOT BE RESPONSIBLE FOR PAYMENT OF COMPENSATION FOR ANY ACCIDENT OCCURRING DURING THE WORK. THE CONTRACTOR IS REQUIRED TO EQUIP HIS LABOURERS/ SUPERVISOR WITH ALL REQUIRED SAFETY EQUIPMENTS, ETC.
24. IF ANY EMPLOYEE OF THE CONTRACTOR IS FOUND COMMITTING ANY MISCONDUCT OR MISBEHAVING, THE PRINCIPAL DISTRICT JUDGE OR AUTHORIZED OFFICER AT ITS DISCRETION MAY ASK THE CONTRACTOR TO REMOVE SUCH EMPLOYEE AND THE CONTRACTOR SHALL REMOVE SUCH EMPLOYEE WITHOUT QUESTIONING THE DECISION OF THE PRINCIPAL DISTRICT JUDGE OR THE AUTHORIZED OFFICER, AND SHALL ALSO ARRANGE FOR SUITABLE REPLACEMENT IMMEDIATELY. THE PRINCIPAL DISTRICT JUDGE WILL BE ENTITLED TO RESTRICT SUCH EMPLOYEE FROM ENTERING THE COURT PREMISES.
25. THE CONTRACTOR SHALL EMPLOY ONLY ADULT WORKERS WITH AGE BETWEEN 18 YEARS TO 50 YEARS AND SHALL ALSO COMPLY WITH ALL THE APPLICABLE LABOUR LAWS PREVALANT DURING THE SERVICE PERIOD. THE CONTRACTOR SHALL ALSO BE SOLELY RESPONSIBLE FOR THE INFRINGEMENT OF ANY SUCH LAWS AND ANY PENAL ACTION AND LIABILITY ARISING THEREOF. THE CONTRACTOR SHALL ALSO FURNISH THE CERTIFICATE OF COMPLIANCE OF THE CONCERNED LABOUR LAWS ON A HALF YEARLY BASIS.
26. THE TENDER SHALL FURTHER CLEARLY SPECIFY THE NUMBER OF MACHINE OPERATORS, SWEEPERS, CLEANERS, GARDENERS, AND SUPERVISORS PROPOSED TO BE DEPUTED UNDER THE CONTRACT.
27. DURING THE PERIOD WHEN THE AGREEMENT SHALL REMAIN IN FORCE, NO CHANGE SHALL TAKE PLACE IN THE TERMS AND CONDITIONS OF THE AGREEMENT REGARDING TAX RATES EVEN IF ANY INCREASED TAX RATE IS IMPOSED BY CENTRAL GOVERNMENT/STATE GOVERNMENT/LOCAL BODY. THE SECOND PARTY SHALL BE SOLELY RESPONSIBLE FOR THE PAYMENT OF INCREASED RATE OF TAX/FUTURE CHARGE/FUTURE SURCHARGE AND THE FIRST PARTY SHALL NOT BE RESPONSIBLE IN ANY MANNER.
