

**Minutes of Meeting of JJC held on 20.08.2019 for State
Conference 2019**

In furtherance of the letter dated 06.08.2019 of Hon'ble Shri Justice Deepak Gupta, Judge Supreme Court of India, a meeting for conducting State Consultation 2019 was convened on 20.08.2019 in the Conference Hall of Madhya Pradesh State Judicial Academy, at Jabalpur. The meeting was chaired by Hon'ble Shri Justice J.K. Maheshwari, Chairperson Juvenile Justice Committee, High Court of M.P. and attended by Hon'ble Smt. Justice Anjuli Palo, Member, Juvenile Justice Committee, High Court of M.P. and following officers:

Emphasis was laid on the issues to be discussed in the National Conference 2019. The issues are as follows:

- De-institutionalization, family and community based alternative care.
- Quality of Services for children (in need of care and protection and in conflict with law): standards of care, compliance, monitoring, mental health and workforce strengthening.
- Youth leaving care: services and challenges.
- Data management and monitoring

After discussion with the officer from UNICEF, DWCD, MPSJA & MPSSA it has been decided that these points are to be analyzed and sub-categorized and thereafter the same should be kept and discussed in the State Consultation.

Further, a discussion has been made on:

1. Date of State Consultation.
2. Place/Venue of State Consultation.
3. Participants for the said consultation.
4. Budget/Expenses for the State Consultation.

After discussion on the above points, it has been decided that 21.09.2019 or 28.09.2019 may be the dates for conducting the State Consultation. Bhopal has been selected for conducting the State Consultation in the month of September, for the venue Shri Anupam Rajan P.S. DWCD has assured that DWCD with UNICEF will find the venue for conducting the said consultation at Bhopal. For the participants/invitees and Budget/Expenses Shri Anupam Rajan Principal Secretary DWCD and Shri Lolichen from UNICEF has assured that they will also look after for the same and inform to the Committee accordingly.

Further it has been discussed that the State Consultation should be attended by each and every stakeholder of Juvenile Justice in the State of Madhya Pradesh and it should be a big event where 350-400 stakeholders should participate in the consultation.


Shri Lolichen from UNICEF Bhopal has thereafter introduced Shri Rajesh Patnaik, from UNICEF New Delhi who demonstrated the Child Protection Management Information System (MIS) working in various States of India. It is integrated software for information of child for juvenile justice. During the course of demonstration, Hon'ble Chairperson was of the view that only collecting figures as Data will not serve the purpose, it will further complicate to access any information. Hon'ble Chairperson was of the view that there should be different MIS at the State Level and Central level and the software should contain information of child from the beginning when child is received in the Juvenile Justice system till his rehabilitation.

Further Hon'ble Chairperson has opined that if the child come for adoption or in CCI or Children in conflict with law, all the proceeding i.e. action from entrance in JJ System till his exit should be implemented in the State level MIS software. His Lordship further added that the schemes and policies of the Government, the fund received and details of utilization of the fund, the actions taken by institutions, CWC, JJB for the said child should be available in the MIS Software so that fault at any stage can be identified. His Lordship has suggested that software should be of such type that on a single click on name of the child his details can be accessed. His

Lordship was of the view that data at National level and State level should be available in the MIS Software.

In the discussion, Shri Rajesh Patnaik UNICEF New Delhi was asked to show demo of MIS software on real time basis, which is presently used by any other state for which he has informed that he doesn't have access to the said software, Shri Kuldeep Singh Kushwah, Chief System Analyst, High Court of M.P. has asked to Shri Rajesh Patnaik to submit SRS of the software so that it can be analyzed and find out what requirements are needed in the software at the National and State Level. Also the Software has the ability to share the data to different stakeholders either through web API's or through intermediate server like integration with SLISA, E-COURTS etc software for better coordination at all level. In the end, a small session for MIS Software has also been directed to be added in the State Consultation to be held in September, 2019 at Bhopal.
