## Respected Ma'am/Sir,

The Juvenile Justice Committee, High Court of Madhya Pradesh receives inspection reports of Child Care Institutions, Specialised Adoption Agency and Child Welfare Committees submitted by Addl. District & Sessions Judges (nominated as Visitor Judges). Through these inspection reports the Juvenile Justice Committee, MPHC monitors the standards of care provided to the children residing in the Child Care Institutions and the functioning of the Child Welfare Committees of the State.

Due to the recent amendment in Juvenile Justice Rules, 2016 it was noticed that the format for the inspection reports submitted by Visitor Judges must be revised. Under the directions of Hon'ble Juvenile Justice Committee, MPHC the Secretariat, JJC has prepared the format of the inspection of Child Care Institutions, Specialised Adoption Agency and Child Welfare Committee. The inspection format is to be used for various institutions and the frequency of submission of reports is provided hereunder:-

As directed by the Hon'ble Juvenile Justice Committee, MPHC the inspection reports submitted in the previous format would not be considered for monitoring the status of the institutions. Therefore, the Addl. District & Sessions Judges (nominated as Visitor Judges) are required to share the inspection reports on a quarterly basis on the new format prepared by the Secretariat, JJC.
