## ORDER

Madhya Pradesh State Judicial Academy, High Court of M.P., Jabalpur is conducting Foundation Course (Second Phase) for the directly appointed Additional District Judges from the Bar from 17.10.2016 to 27.10.2016 in the Academy. Judges, whose names and postings figure in the endorsement are directed to attend the aforesaid course.

Conditions for the course:

- 1. Barring exceptional circumstances, the participants nominated for the Course shall not pray for adjustment.
- 2. The participants shall report by **9.30** a.m. on **17.10.2016** in the Lecture Room of Madhya Pradesh State Judicial Academy, Jabalpur.
- 3. The participants shall appear for the course in prescribed uniform (i.e. Black coat, white shirt, grey trousers and black tie.) during entire duration of the course.
- 4. The participants shall bring alongwith them detailed synopsis of the work done by them after the First Phase Foundation Course in the Academy in their respective district headquarters

- 6. T.A. & D.A. of the participants is reimbursable only as per Government Rules.
- The Academy shall endeavour to make best possible arrangements for reception, lodging and boarding of the participants in the Guest House of the Academy.
