- 6. The Principal District & Sessions Judge, Indore shall make all necessary arrangements for the conduction of the aforesaid programme in consultation with the Director, MPSJA which includes the arrangements for:
 - (i) local conveyance (pick and drop vehicles from Railway Station/ Bus Stand to place of venue) for the participant Judges as per Programme.
 - (ii) tea twice, working lunch and high tea for the participants, faculties and invitees.
 - (iii) photography and stationery which includes folders, pens & note pads etc.
- 7. The Principal District & Sessions Judge, Indore is further directed to depute one Judicial Officer, one Class III & Class IV employees for assisting MPSJA. The Judicial Officer and employees so deputed shall be paid honorarium/incentive as per High Court Order dated 26.08.2016.
- Budgetary allocation of **Rs. 1,60,000**/- (Rupees One lakh sixty thousand only) will be made to the Principal District & Sessions Judge, Indore vide a separate order of the High Court to meet the expenses of the said programme. All expenses shall be made within the limits of the budgetary allocation as per the approved Scheme. After making all payments, the details of the expenditure along with the copies of the bills shall be forwarded to the Director, MPSJA.
- 9. No arrangements for accommodation will be provided to the participants by the MPSJA. The participants attending the Programme are entitled for TA/DA as per the rules which may be reimbursed from the funds made available to the concerned Principal & Sessions Judges separately for this purpose.

- The participant Judges shall be provided with local conveyance (only pick and drop vehicles) from Railway Station/ Bus Stand to place of venue during the programme.
- 11. The officers nominated are directed to arrange their Board Diary in such a manner that no case is listed on the dates, on which they are directed to attend this training. If, cases have already been fixed for the said dates, summons should not be issued and if it is issued, the parties should be informed about the change in dates.
- 12. The participant Judges should not seek any adjustment or exemption unless it is a case of *vis-major*.
