 - to attend the Conference soberly dressed.
- 7. The Principal District & Sessions Judge Gwalior/ Datia/ Guna/ Shivpuri/ Morena/ Bhind/ Ashoknagar/ Vidisha for information and necessary action with a request to instruct the participant Judges to remain present at Regional Training Centre, Gwalior, High Court of Madhya Pradesh, Bench at Gwalior on the date and time given in the order, positively.

- 8. The Principal District & Sessions Judge, Gwalior shall make all necessary arrangements for the conduction of the aforesaid programme in consultation with the Director, MPSJA which includes the arrangements for:
 - (i) local conveyance (pick and drop vehicles from Railway Station/ Bus Stand to place of venue) for the participant Judges as per Programme.

- (ii) tea twice, working lunch and high tea for the participants, faculties and invitees.
- (iii) photography and stationery which includes folders, pens & note pads etc.
- The Principal District & Sessions Judge, Gwalior is further directed to depute one Judicial Officer, one Class III & Class IV employees for assisting MPSJA. The Judicial Officer and employees so deputed shall be paid honorarium/incentive as per High Court Order dated 26.08.2016.
- 10. Budgetary allocation of **Rs. 1,60,000/-** (Rupees One lakh sixty thousand only) will be made to the Principal District & Sessions Judge, Gwalior vide a separate order of the High Court to meet the expenses of the said programme. All expenses shall be made within the limits of the budgetary allocation as per the approved Scheme. After making all payments, the details of the expenditure along with the copies of the bills shall be forwarded to the Director, MPSJA.
- 11. No arrangements for accommodation will be provided to the participants by the MPSJA. The participants attending the Programme are entitled for TA/DA as per the rules which may be reimbursed from the funds made available to the concerned Principal & Sessions Judges separately for this purpose.
