A 5-day Seminar on 'POCSO & Child Protection' is scheduled to be held at SVP National Police Academy, Hyderabad on **October 06<sup>th</sup> -10<sup>th</sup>, 2025** for the Officers of the rank of Dy. SP to ASP and above and also for officers of equivalent rank from Judiciary, FSL, District child protection officers and prosecution officers.

**2. The objective of the Seminar to enable the participants:**

- To develop a better understanding of the scale and magnitude of sexual offences against children.
- To better appreciate the existing laws, procedures, coordination systems among various agencies.
- Prevention of such crimes
- To re-emphasize and develop a deeper understanding of the victim-centric approach in the quest for justice.
- Analyse the limitations and constraints in investigation, prosecution and inter-agency coordination to suggest ways and means for their resolution and
- Appreciate the various aspects with a view to exploring new strategies and tactics for effective tackling of such crimes.

The Seminar is fully residential and the participants of the seminar will be staying in the accommodation provided by the Academy. **The expenditure to be incurred on boarding and lodging of the participants shall be met by the Academy, in respect of all Officers attending the Seminar.** However, the expenditure on account of travel of officers for attending the seminar may be borne by the respective State / Central Government Departments. It is informed that as per SOP of the Academy, those Officers against whom any criminal case, DE/PE etc. is in currency or contemplated are **not eligible** to undergo any training programme/course/seminar at the Academy. Hence, nominations of eligible Officers may only be sent accordingly.

7. The nominees may be advised to proceed for the course only after receiving confirmation of acceptance of their nominations from the Academy. The Officers nominated for the seminar are required to report at the Academy by the evening of 05<sup>th</sup> October, 2025 i.e. one day before the commencement of the course.
