In case, cases have been fixed for the said dates, Summons should not be issued and if Summons are issued, then the parties should be informed about the change in dates.

- As the Hostel accommodation is limited, Officers nominated for the Course are encouraged to make their own arrangement of accommodation, if possible.
- To claim their dues like lodging, boarding etc. in their T.A Bills before the respective District Judge.
- To bring Laptop during the training programme.
