 Certificate to be submitted at reception of MPSJA on arrival.
- to apprise themselves with the contents of the Joining Instructions available on the MPSJA website www.mpsja.mphc.gov.in and observe the same.
- to attend the Course in prescribed uniform i.e. Black coat, white shirt, grey trousers and black tie in case of men and white saree and blouse with black coat, in case of ladies.
- the participant District Judges shall follow all COVID-19 pandemic protocol like wearing mask, observing social distancing, sanitization etc. during the Course as well as during their stay in MPSJA.
- since this Course is mandatory, the participant District Judges shall not seek
 exemption except in case of vis major. Under such a circumstance, the
 application shall be forwarded to the MPSJA after due examination/
 verification from the respective Principal District Judge accompanied with
 their report.
