 - the participant Judges shall not seek exemption except in case of *vis major*. Under such a circumstance, the application shall be forwarded to the MPSJA after due examination/ verification from the respective Principal District & Sessions Judge accompanied with their report.
 - to send their travel itinerary to the Academy well in advance via email at dirmpsja@mp.gov.in.
 - duly filled in Registration form shall be positively submitted by the participant Judges on their arrival in the Academy.
