## **ORDER**

Madhya Pradesh State Judicial Academy, High Court of M.P., Jabalpur is conducting Workshop on Land Acquisition Act, 1894 including Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 for the Judges dealing cases under the Act on 27.08.2016 & 28.08.2016 in the Academy.
