Conditions for the course:

- 1. Barring exceptional circumstances, the participants nominated for the Course shall not pray for adjustment.
- 2. The participants shall report by **9.30 a.m**. on **05.09.2016** in the Lecture Room of Madhya Pradesh State Judicial Academy, Jabalpur.
- 3. The participants shall appear for the course in prescribed uniform (i.e. Black coat, white shirt, grey trousers and black tie in case of men and white saree and blouse with black coat in case of ladies) during the entire duration of the course
- 4. The participants shall bring with them the records prepared by them regarding the task entrusted to them during their Second Phase Field Training.
- 5. The participants may send legal problems which they want to be addressed during the course to the Academy by fax (No. 0761-2628679) sufficiently in advance.
- 4. T.A. & D.A. of the participants is reimbursable only as per Government Rules.
- The Academy shall endeavour to make best possible arrangements for reception, lodging and boarding of the participants in the Guest House of the Academy.
