In order to prevent the spread of infection of Corona Virus amongst the officers and employees directions were issued vide Registry Order No A/1649 dated 17.07.20, not to attend religious functions, marriages and other social gathering without prior permission and information of the Controlling Authority. It is observed that instructions are not being followed.

It is therefore, again ordered that employees shall not attend any mass gathering like, marriage, religious function, or any social gathering without prior information and permission of the office. Further, they shall not leave the Headquarter, without prior information and sanction. Any deviation from the above directions shall be view seriously and the employee concerned shall be liable for disciplinary action.
