

NOTES :-

1. New Year's Holiday dated 01.01.2023, Makar Sankranti dated 15.01.2023 & Deepawali dated 12.11.2023 falls on Sunday therefore these holidays are not declared separately.
2. Saturdays falling on 21st January, 18th February, 18th March, 15th April, 20th May, 17th June, 15th July, 19th August, 16th September, 21st October, 18th November, 16th December will be closed Saturdays of District Judiciary.
3. Summer Vacation of District Judiciary shall be from 15th May 2023 to 9th June, 2023 and Winter Vacation from 25th December 2023 to 31st December, 2023.
4. District Judiciary will not observe the holidays declared or changed suddenly by the State Government/Competent Authority without approval of High Court.
5. The Principal District Judge of the concerned district shall declare three Local holidays declared by the Collector/Commissioner of the concerned District or Tehsil without approval of the High Court under intimation to this Registry.

6. The holidays in respect of Id-ul-Fitar, Id-ul-Zuha, Moharrum and Id-milad un-Nabi are subject to change depending upon the visibility of moon.
7. Due to uncertainty relating to Holi (Dhuredi) festival, if it falls on 8th March, then 7th March will be working day and if it falls on 7th March then 8th March will be working day as per the calendar.
