Applications are invited for empowerment as **Commissioner of Oaths (for the High Court)** against vacancy of **08 posts** for the **Principal Seat at Jabalpur** from the advocates who possess qualifications as prescribed in Rule 4 of the Commissioner of Oaths (for the High Court) Rules, 2008, hereinafter, referred to as 'the Rules' and which reads as under :

**4. Qualifications** - an advocate shall not be qualified for empowerment as Commissioner of Oaths for the High Court, unless he :-

- (i) is registered with the State Bar Council of Madhya Pradesh.
- (ii) has been continuously practising for a period of not less than 7 years on the date of application and
- (iii) is a member of the -
  - (a) High Court Bar Association at Jabalpur, Indore or Gwalior; or
  - (b) District Bar Association of other districts,
    - in which he desires to be empowered, for a period of not less than 3 years immediately preceding the date of application.

Every application must be submitted in prescribed **Form-I** as provided under the Rules, 2008 (*supra*) which must be accompanied by non-refundable **fee of Rs. 100/-** payable through **postal order** drawn in the name of **Registrar General, High Court of M.P., Jabalpur**, alongwith, documents as required as per note appended to the Form-I. Applicants are also required to submit copy of certificate of birth, caste certificate (if applicable) and disability certificate (if applicable).

Application completed in all respects must be submitted in the **Receipt Section of the High Court of M.P. Jabalpur, within 15 days** from the date of this notification.

### COMMISSIONER OF OATHS (FOR THE HIGH COURT) RULES, 2008

No. 79-O.S.D.—Preamble.—In exercise of powers conferred by section 3(2)(a) of the Oaths Act, 1969, Articles 225 & 227 of the Constitution of India, Sections 122 and 139 (b) of the Code of Civil Procedure, 1908 (5 of 1908), Sections 477 (1) (d) and 297 (1)(b) of the Code of Criminal Procedure, 1973, Clauses 27 and 28 of the Letters Patent and all other powers enabling it in this behalf, the High Court of Madhya Pradesh hereby makes following Rules to empower an advocate to function as Commissioner of Oaths for the High Court and all matters incidental thereto.

1. **Short title and Commencement.**—(1) These rules may be called the "Commissioner of Oaths (for the High Court) Rules, 2008".

(2) These Rules shall come into force on the date of publication in the Official Gazette.

**2. Definitions.**—In these rules, unless the context otherwise requires,—

- (a) “**Affidavit**” shall include affirmation and declaration in the case of persons by law allowed to affirm or declare instead of swearing;
- (b) “**Commissioner of Oaths for the High Court**” means an advocate empowered to administer oath to or receive affirmation from the affiant in respect of an affidavit to be filed in the High Court for the purpose of judicial proceedings;
- (c) “**Empowerment**” means authorization of an advocate by the empowering authority to perform the functions and discharge the duties of the Commissioner of Oaths for the High Court;
- (d) “**Empowering Authority**” means the High Court of Madhya Pradesh on the administrative side;
- (e) “**Form**” means a form appended to these rules;
- (f) “**High Court**” means the High Court of Madhya Pradesh;
- (g) “**Registrar**” means an officer defined as Registrar, under the High Court of Madhya Pradesh Rules.

**3. Jurisdiction.**—The Commissioner of Oaths shall have the power to verify affidavits to be filed in the High Court for the purpose of judicial proceedings by administering oaths on or receiving affirmation from the affiants.

**4. Qualifications.**—an advocate shall not be qualified for empowerment as Commissioner of Oaths for the High Court, unless he :—

- (i) is registered with the State Bar Council of Madhya Pradesh,
- (ii) has been continuously practising for a period of not less than 7 years on the date of application and
- (iii) is a member of the,—
  - (a) High Court Bar Association at Jabalpur, Indore or Gwalior; or
  - (b) District Bar Association of other districts,,  
-in which he desires to be empowered, for a period of not less than 3 years immediately preceding the date of application.

**5. Sanctioning of Strength and Notification of Vacancy.**—(i) The empowering authority may, from time to time, sanction such strength of Commissioner of oaths for the High Court for each civil district, as it may deem fit.

(ii) The Registrar / District Judge shall notify the vacancy in accordance with the strength sanctioned under sub-rule (i), to the concerned bar association and invite applications from advocates for being empowered as Commissioner of Oaths for the High Court.

**6. Application for Empowerment and Preparation of Panel.**—(i) Every application for being empowered as the Commissioner of Oaths for the High Court shall be made in Form-I within 15 days from the date of notification of vacancy and shall be accompanied by a non-refundable fee of Rs. 100/- payable through a postal order in the name of the Registrar General of the High Court of Madhya Pradesh, Jabalpur.

(ii) The Registrar for the districts of Jabalpur, Indore and Gwalior and the concerned District Judge for other districts shall prepare a panel of advocates in order of merit keeping in view their suitability for such empowerment and submit the same to the empowering authority.

**7. Empowerment of Advocates as Commissioner of Oaths for the High Court.**—The empowering authority shall, at its discretion, empower advocate (s) as Commissioner (s) of Oaths for the High Court, out of the panel mentioned under sub-rule (ii) of rule 6.

**8. Term of Commissioner of Oaths for the High Court.**—The Commissioner of Oaths for the High Court shall be empowered for a period of three years. A certificate to that effect shall be issued by the Registrar / District Judge, on deposit of a fee of Rs. 750/- by the person so empowered, through a treasury challan, within a period of 21 days from the date of communication of the order of empowerment.

**9. Register of Commissioner of Oaths for the High Court.**—(1) The Registrar / District Judge shall enter the name of Commissioner of Oaths for the High Court in the Register maintained in Form No. II.

(2) The Registrar / District Judge shall issue to such person a certificate of empowerment in Form no. III on payment of prescribed fee.

**10. Work Place.**—Every Commissioner of Oaths for the High Court shall have a work place at the station mentioned in the certificate of empowerment and shall exhibit such certificate in a conspicuous place therein.

He shall also display his name and designation as Commissioner of Oaths for the High Court on a name-plate (60 cm x 45 cm in size) outside such work place.

The Commissioners of Oaths shall make their services available during Court hours in the High Court bar room in districts of Jabalpur, Indore and Gwalior and in District bar room in other districts.

**11. Seal.**—(i) The Commissioner of Oaths for the High Court shall use a circular seal of the diameter of 5 cm, bearing his name and name of the civil district for which he has been empowered to exercise his function and the circumscription "Commissioner of Oaths for the High Court."

(ii) The Commissioner of Oaths for the High Court shall affix his signature and the seal, mentioned under sub-rule (i), on every page of the affidavit and every page of the petition, application, return, rejoinder or other document, supported by such an affidavit.

**12. Duties.**—It shall be the duty of Commissioner of Oaths for the High Court to ensure that the affidavit is drawn up and verified strictly in accordance with the rules, pertaining to affidavits as contained in the High Court of Madhya Pradesh Rules and these rules.

The Commissioner of Oaths for the High Court shall not, under any circumstances, delegate any part of his duty to anyone.

**13. Fee Chargeable by the Commissioner of Oaths for the High Court.**—The Commissioner of Oaths for the High Court shall be entitled to charge a fee of Rs. 25/- per affidavit or such other fee as may be fixed by the empowering authority from time to time. He shall grant receipt in Form No. IV for the fee charged / realized by him.

**Explanation.**—The Commissioner of Oaths for the High Court shall be entitled to charge the actual railway fare of second class or actual bus fare when he is required to attend any place outside his work place or court premises; but within the District.

**14. Register to be maintained by the Commissioner of Oaths for the High Court.**—(a) The Commissioner of Oaths for the High Court shall maintain a register in Form V and shall enter the details of every affidavit verified by him in it soon after its verification and shall obtain signature of the affiant thereon.

(b) The Commissioner of Oaths for the High Court shall, as and when directed, submit for inspection by the Registrar / District Judge or any such officer as the empowering authority may appoint in this behalf, the register maintained by him under sub-rule (a) above.

(c) The Commissioner of Oaths for the High Court shall make entry fee charged / realized by him, in the register maintained under sub-rule (a).

(d) The Commissioner of Oaths for the High Court shall duly number every page of such register and get it verified by the Registrar / District Judge before making any entry therein.

**15. Submission of Returns.**—The Commissioner of Oaths for the High Court shall, on or before 7th January, 7th April, 7th July and 7th October, submit to the Registrar / District Judge the quarterly return of work done by him as Commissioner of Oaths for the High Court during the preceding quarter, in Form VI accompanied by a photo copy of all the entries of the register for the relevant period, certified by the commissioner to be true.

**16. Renewal of Empowerment.**—(1) The certificate of empowerment may be renewed for a period of three years by the Registrar / District Judge, with prior approval of the empowering authority on an application made in Form No.VII, by the concerned Commissioner, on the deposit of a non-refundable fee of Rs. 750/- through a treasury challan :

Provided that such renewal shall not be made for more than two terms whereafter the Commissioner of Oaths for the High Court shall not be eligible for re-empowerment.

(2) The application for renewal of certificate shall be made to the Registrar / District Judge concerned, 90 days before the date on which the term under the existing empowerment expires:

Provided that a delay up to 45 days may be condoned by the Registrar / District Judge, if it is shown that the delay occurred due to sufficient cause. Such application shall be decided within a period of 7 days.

No application for condonation of delay shall lie after expiry of the period of 45 days.

In the case of rejection of such application, a representation may be made within 7 days, to the empowering authority, whose decision thereon shall be final.

(3) On renewal of empowerment, a certificate in form VIII shall be issued by the Registrar/District Judge.

**17. Misconduct.**—Where Commissioner of Oaths for the High Court fails to ensure compliance with the provisions of these rules or commits any act unbecoming of an Oath Commissioner, he shall be deemed to have committed misconduct for the purpose of rule 18 of the Rules.

**18. Inquiry into allegations of misconduct.**—(a) An inquiry into the misconduct of Commissioner of Oaths for the High Court may be initiated either *Suo Moto* by the empowering authority, the Registrar or the concerned District Judge or on a complaint received by any of such authorities.

(b) Where an inquiry is initiated *Suo Moto* by any of the authorities referred to in the forgoing sub-rule, the Registrar / District Judge shall send to the Commissioner of Oaths for the High Court a statement specifying the charge (s) against him together with particulars of oral or documentary evidence relied upon in support of such charge (s) and in other cases, supply a copy of complaint received by such authority.

(c) The Registrar / District Judge, after giving to the person making the allegation, in case of inquiry started on a complaint as well as to the Commissioner of Oaths for the High Court against whom such allegation is made, an opportunity of being heard and after taking into consideration any oral and /or documentary evidence, that may have been produced before him, shall make a report to the empowering authority:

Provided that the Registrar / District Judge may dispense with such inquiry and make report to the empowering authority under sub-rule (c) after receiving reply of the Commissioner of Oaths for the High Court, where he considers such inquiry to be unnecessary under the circumstances of the case.

(d) If the empowering authority, after considering the report of the Registrar / District Judge, is of opinion that action should be taken against Commissioner of Oaths for the High Court, the empowering authority may either,—

- (i) cancel the certificate of empowerment, entailing disqualification for further empowerment;
- (ii) suspend his empowerment for a specified period;
- (iii) warn him according to the nature and gravity of the misconduct proved; or
- (iv) make any other order as it thinks fit.

**19. Removal.**—(1) The empowering authority may remove the Commissioner of Oaths for the High Court on his being mentally or physically incapacitated to perform his duties permanently or on his conviction for an offence.

(2) The empowering authority may, in the circumstances of exceptional nature, withdraw the empowerment of any advocate as Commissioner of Oaths for the High Court without assigning any reason therefor.

**20. Cessation of Empowerment.**—The empowerment of an advocate as Commissioner of Oaths for the High Court effected under rule 7 of the these rules shall stand ceased,—

- (i) on expiry of the term of empowerment if the certificate is not renewed before such expiry; or
- (ii) on his attaining age of 70 years; or
- (iii) on his tendering resignation in writing, subject to its acceptance by the empowering authority; or
- (iv) on cancellation of his certificate of empowerment under rule 18 or his removal under rule 19; or
- (v) on his appointment as a Notary Public under the Notaries Act, 1952 (53 of 1952); or
- (vi) on his securing private or public employment; or
- (vii) on his ceasing to work as such for a continuous period of two months except where such conduct is condoned by Registrar / District Judge concerned; or
- (viii) On his ceasing to be an advocate for any reason; or
- (ix) on his incurring any punishment under Section 35 (3) of Advocates Act, 1961; or
- (x) on his death.

**21. Delegation of Powers.**— The empowering authority may delegate all or any of its powers under these rules, to a Judge of the High Court or a committee comprising such Judges of the High Court, as may be nominated by the Chief Justice.


