However, all matters pertaining to examination conducted by VYAPAM shall be listed before Division Bench of Hon'ble the Chief Justice at Principal Seat Jabalpur, Shri Justice P.K. Jaiswal at Bench Indore and Shri Justice Sheel Nagu at Bench Gwalior, if available. Otherwise, such matter shall be listed before the available Division Bench during vacation.

Further, if cases listed before the Vacation Court(s) are 'Not Reached', the concerned Vacation Court may issue direction for listing of such Cases on the following day subject to availability and convenience. Otherwise, The said matters be listed before the Vacation Court available on specified day accordingly.

Further, as per resolution passed in the meeting with representatives of Bar Associations Jabalpur held on 10.04.2017, 11.04.2017 and 17.04.2017 in the Chamber of Hon'ble the Chief Justice and in the meeting of representatives of Bar Associations with the respective Hon'ble Administrative Judges of Bench at Indore and Gwalior, the Criminal Appeals in which accused are in Jail for more than 10 years and other Criminal Matters upto the year 2005, Miscellaneous Appeals on the basis on compromise, Writ Petitions relating to dismissal and pension prior to year 2008, all other infructuous & covered writ matters, MCC and CONC shall be listed as per the programme before respective Division Benches and Single Benches during the first week of the Summer Vacation from 22.05.2017 to 26.05.2017 at Principal Seat at Jabalpur and its Benches at Indore and Gwalior.
