However, any objection/ clarification received without any authentic proof/source or any objection/clarification received after aforesaid stipulated period/time shall not be entertained/ considered on any ground whatsoever and shall stand rejected without assigning any reason.


Objections received in aforesaid manner within aforesaid time limit alongwith self attested copies of the source/proof, document shall be considered and the Model Answer shall be finalized and used as Key/model Answer for the generation of result of the Online Exam of Junior Judicial Assistant (High Court) -2021.

After declaration of result, no representation regarding Question/ final Model Answer, shall be entertained on any ground and shall stand rejected without assigning any reason.

In case no objection is received within prescribed time then proposed model answer key shall be treated as final and result will be generated accordingly.
