It is being observed that despite of repeated directions the employees of the Registry are not following the COVID-19 protocol while attending office. It is therefore ordered that the officers and employees of the Registry shall follow the safety precautions to avoid spread of COVID-19 infection during working hours such as maintaining social distancing, wearing of mask, using hand sanitizers etc., failing which they shall be liable for disciplinary action.

It is further ordered that if the officers and employees of the Registry/their family members are found positive of COVID-19 infection shall immediately submit the information to the Registry. Further that if they or their family members have symptoms of COVID-19 infection shall not attend the office till their recovery from the same.
