- Principal District Judges and Principal Judges / Addl. Principal Judges,

- Judicial Officers on deputation shall also make suitable arrangements for urgent work in their respective jurisdictions.
- In case of any urgency, participant Judicial Officers may seek exemption from Principal District Judges / Principal Judges Family Court / Competent Authority, as the case may be.
- 5. The Judicial Officers attending the said programme shall be entitled for T.A./D.A as per Rules. They shall submit their T.A./D.A. bill to their concerned Establishment.
- Judicial Officers may use their allotted official vehicle or any other mode of transport for attending the said programme. Travelling time may be claimed as per Rules.



7. The Judicial Officers are directed to dress up soberly in order to maintain decency during the programme.
