Subject:- <u>Updation of statistical information</u> regarding pendency, institution and <u>disposal from Subordinate Courts</u>.

In compliance of the directions issued earlier, the data regarding pendency, institution and disposal of cases of various nature on civil and criminal side in different Courts is being uploaded on the website of the M.P. High Court www.mphc.in by the District Court with the help of link (www.mphc.in/dc\_statement).

In order to get exact status of pendency, institution and disposal at a given point of time it is thought appropriate to retrieve the data from the website of the High Court. This requires that data is updated on monthly basis and a report is sent through email to the Checker Section that the same has been updated latest by 7th day of following month. Availability of the data online in updated form will obviate the need of calling statistical report in hard copy from time to time from District Court. It will also save a lot of time and

manpower in preparing the information sought in this respect.

Therefore, as directed, I wish to request you to ensure that the SW Section and System Officers coordinate in such a manner that statistical information regarding pendency, institution and disposal of cases of a particular month is positively and invariably uploaded a particular who the website so that it is available with the High Court

I also wish to request you, as directed, that the practice of sending statistical monthly information in hard copy should be stopped with effect from 1st October, 2015, meaning thereby that the statements up to 31st August, 2015, which would be uploaded on the website in the 1st week of September, shall be forwarded to the High Court through email at email i.e. mphchk@gmail.com as well as in hard copy but the information from the next following month i.e. from October shall be sent only through email so as to reduce use of papers as well as to get the information without any delay.
