Hon'ble the Computer and e-Court committee of the High Court in its meeting dated: 16th May, 2020 has resolved to recommend as under:-

"The exemption be granted only in tender fees for the firms / vendors registered with NSIC and MSME but they have to deposit EMD (earnest money deposit) in the form of demand draft / pay order / FDR / unconditional Bank Guarantee or in any other form as per directions of High Court of M.P., Jabalpur along with the tender document."

Hon'ble the Chief Justice vide order dated: 27.05.2020 has been pleased to approve the recommendation of Computer and e-Court Committee meeting dated: 16.05.2020 and permit to grant the exemption of tender fees to the firms registered with NSIC and MSME but the firms / vendors have to deposit EMD (earnest money deposit) along with the tender document .
