Shri Soumitra Dinesh Joshi S/o Shri Dinesh Joshi, 207, Indore Centre, M.G.Road, Oppo. High Cout, Indore M.P., is appointed as Legal Assistant/ Law Clerk-cum-Research Assistant in the High Court of Madhya Pradesh, Bench Indore, w.e.f. 16.01.2024 against the Choice Quota of Hon'ble Shri Justice Subodh Abhyankar for a period of 01 year on monthly stipend of Rs. 30,000/- on terms and conditions mentioned below:-

- (i) The contractual engagement shall not confer upon the Legal Assistant/Law Clerks-cum-Research Assistant any right/claim for regular appointment or continuance in service beyond the period of engagement in the High Court.
- (ii) The Legal Assistant/Law Clerks-cum-Research Assistant may be prematurely discharged without any notice.
- (iii) The Legal Assistant/Law Clerks-cum-Research Assistant intending to prematurely leave the engagement shall be required to give at least one month prior notice in writing through the Secretary to the Hon'ble Judge with whom he/she is attached as Legal Assistant/Law Clerks-cum-Research Assistant.
- (iv) The Legal Assistant/Law Clerks-cum-Research Assistant shall maintain absolute devotion to duty and a high standard of morals during the term of engagement. The Legal Assistant/Law Clerks cum-Research Assistant shall maintain the highest standard of integrity commensurate with the responsibilities entrusted to him/her. The Legal Assistant/Law Clerks-cum-Research Assistant shall maintain utmost secrecy in respect of matters which come to his/her notice by virtue of the engagement, and shall ensure that no information, document or any other thing is disclosed, parted or disseminated with others, in any manner. The Legal Assistant/Law Clerks-cum-Research Assistant will not disclose any fact which comes to his/her knowledge on account of such official attachment, even after completion of term of engagement, unless such disclosure is legally required in discharge of lawful duties.
- (v) The Legal Assistant/Law Clerks-cum-Research Assistant will not accept any other assignment during the term of engagement as Legal Assistant/Law Clerks-cum-Research Assistant. The Legal Assistant/Law Clerks-cum-Research Assistant shall not practise as an Advocate in any Court of Law or Tribunal or any other authority during the course of the engagement as Legal Assistant/Law Clerks-cum-Research Assistant.
- (vi) The Legal Assistant/Law Clerks-cum-Research Assistant shall not appear before the Hon'ble Judge to whom he/she has been attached for a minimum period of one year after the completion of engagement.
- (vii) The Legal Assistant/Law Clerks-cum-Research Assistant, for a period of three years after the completion of the engagement, will not

appear in a case handled by the Hon'ble Judge to whom he/she has been attached, regardless of whether he/she worked on that case or not during the period that he/she worked with the Hon'ble Judge.

- (viii) Legal Assistant/Law Clerks-cum-Research Assistant, while on duty, shall wear the following as part of their uniform
 - a. Male Legal Assistant/Law Clerks-cum-Research Assistant shall wear plain white collared shirt, black tie, plain black coat with two buttons, plain black trouser and black shoes with socks.
 - b. Female Legal Assistant/Law Clerks-cum-Research Assistant shall wear plain white collared shirt, black tie, plain black coat with two buttons, plain black trouser and black shoes with socks.

Or

Shall wear plain white salwar with white collared kameez, plain black coat with two buttons and black shoes with socks or other footwear in black colour.
