- ii. shall wear the uniform while making or subscribing to an oath or affirmation as follows:
 - a. for male Judicial Officers: plain white collared shirt, white band, plain black coat or plain black buttoned-up coat, barrister striped (bar-at-law) or plain black or plain white trouser, black gown and black shoes with socks.

- iii. stay, lodging and boarding shall be arranged by the Madhya Pradesh State Judicial Academy, Jabalpur as per their rules and norms and necessary instructions in this regard shall be issued by the Madhya Pradesh State Judicial Academy, Jabalpur in due course.
- iv. shall be entitled to bring only two persons to witness the oath ceremony. However, such persons shall have to make their own arrangement of stay, lodging and boarding.
- v. after the oath ceremony, shall undergo an orientation programme at the Madhya Pradesh State Judicial Academy, Jabalpur as per the schedule issued in this behalf. He shall report in the Acadamy accordingly.
- vi. posting orders may be issued and given to these newly appointed District Judges (Entry Level) at the end of the orientation programme and they shall be directed to join their respective place of posting as per direction.
