In compliance of the directions of Honourable the Supreme Court of India, given in Writ Petition (Civil) No. 699/ 2016, *Ashwini Kumar Upadhuaii versus Union of India and Anr*, the Court, particularised in the following table is hereby designated as Special Court under scheme for setting up of Special Courts to deal with criminal cases involving political persons for trial of cases, registered against the elected 'Members of Parliament and Members of Legislative Assembly, former or sitting, in the State of Madhya Pradesh.

The designated Court is hereby also notified for trial of cases relating to VYAPAM scam matters and matters linked thereto and all cases, in which offences have been investigated by the Central Bureau of Investigation, filed against the elected Members of Parliament and Members of Legislative Assembly, former or sitting, in the State of Madhya Pradesh.

The designated Court of Additional Sessions Judge is hereby also notified as Court as specified under section 153(2) of the Electricity Act, 2003 and under section 36(2) of the NDPS Act, 1985 for trial of cases filed against the elected Members of Parliament and Members of Legislative Assembly, former or sitting, in the State of Madhya Pradesh.

The Headquarter of the Special Court and the respective jurisdiction will be as detailed in the table.

This notification is issued by making amendment in earlier notification(s) No. B/8125 dated 14.12.2021, A/2828 dated 10.04.2024 & A/8744 dated 17.12.2024 issued by the High Court of M.P. in this regard.
