In exercise of the powers conferred by sub-section 2 of the Section 9 of the THE BHARATIYA NAGARIK SURAKSHA SANHITA, 2023 (No. 46 of 2023) the High Court of Madhya Pradesh hereby appoints the Judicial Magistrate First Class mentioned in Column No. 2 of the table below to be the Presiding Officer of the Court of Special Magistrate established by the Government of Madhya Pradesh for the trial of offences of Railway Property (Unlawful Possession) Act, 1966 (No. 29 of 1966) and under Section 137 to 147, 150 to 157, 159 to 168, 172 to 176 of the Indian Railways Act, 1989 (Act No. 24 of 1989) and for all other penal provisions of this Act in which Judicial Magistrate First Class is authorised to take cognizance, arising out of territorial jurisdiction of Railway Lands running through the territories of Revenue Districts shown in Column No. 4 of the said table with effect from the date of assumption of charge by the Magistrates. The Headquarter of the Court will be as mentioned in Column no. 3 of the table.
