
NOTIFICATION

In continuation of Advertisement No. 65/Exam/LCE/2024 dated 25.04.2024, it is to notify that the objections against proposed Model Answer Keys of 1st Question Paper (MCQ type) of Limited Competitive Exam-2024 under Rule 5(1)(b) of Madhya Pradesh Higher Judicial Service (Recruitment and Conditions of Service) Rules, 2017 for the post of District Judge (Entry Level), held on 07.07.2024, were invited by way of Notification No. 85/Exam/LCE/2024 dated 08.07.2024.

After considering all received objections, proposed answer of Question No. 29 has been changed from option "B" to option "A" and answer of Question No. 57 has been changed from option "C" to option "A". The rest of the objections in respect of other proposed model answer keys have been rejected. Accordingly, result has been prepared.
