- 1- Total Vacancy Advertised were 9 (UR-05, OBC-01, SC-01 & ST-02). As per Rule 6 of M.P. H.J.S. (Recruitment and conditions of Service) Rules, 1994, if sufficient no. of candidates belonging to S.C./S.T. and O.B.C. are not available such posts shall be treated as "Unreserved". Hence, all 9 posts advertised are filled by the U.R. candidates.
 - 2- Only 05 Posts out of 69 Posts could be filled rest 64 Posts under proviso to Rule 5(1)(c) through promotion from Senior Civil Judges still remained unfilled. On the basis of order of Hon'ble the High Court dated 04.02.2016, 3 Posts are being filled by the Advocates who have fulfilled the benchmark specified for such appointment, hence 3 posts are filled by the Advocates who have fulfilled the benchmark specified for such appointment.
 - 3- On the basis of above provisions, all 12 candidates are eligible for selection subject to approval of Full Court of Hon'ble High Court.
 - 4- Hon'ble the High Court in Writ Petition No.308/2016, W.P. No.5092/2016 & R.P. No.248/2016 by order dated 29.04.2016 has made clear that all steps taken on the basis of amended provisions, will be subject to the outcome of these petitions, hence this result and further steps taken will be subject to decision of the aforementioned petitions.
 - 5- A person whose name appears in the Select List does not acquire any indefeasible right to appointment.
 - 6- If at any stage of selection or appointment or post appointment stage, any information or document or certificate or testimonial of any candidate, mentioned in this list, is found to be false or fabricated or forged, his or her candidature / selection or appointment may be cancelled without any prior notice.
