1. Application:

Online application forms from the eligible candidates are invited through the link provided by the Examination Section within prescribed time. The eligible candidates desiring to appear in Examination shall submit their online application forms on or before <u>05/06/2023</u>.

The application(s) submitted after due date shall be rejected out-rightly. The candidate(s) who has/have not applied for the Exam shall be treated as "unwilling" to appear in the Exam.

2. Procedure for submitting Online Application Form :-

A link for filling the online application form is provided for all eligible candidates on the website of High Court of Madhya Pradesh (www.mphc.gov.in). By clicking on the provided link the application form will get open, after filling the Application Form, candidate have to click on "browse" button to upload recent Color Photo and Signature (only in *jpeg* format). Thereafter, candidates are advised to check the preview of Application Form, if all entries are correct then click on "submit" button otherwise click on "reset" button to modify the entry.

- Note:- 1. Candidates are required to read all information carefully before submitting the Application Form as there is no provision for correction of the same after final submission.
 - 2. Candidates are advised to keep a printout of the finally submitted application form.

3. Admit cards:-

Admit Cards shall be generated about 05 days prior to the date of examination and shall be made available on the website of High Court of Madhya Pradesh (www.mphc.gov.in). Candidate(s) will have to download and keep a hard copy of the same. Admit Card shall be issued only to those candidates whose application forms are submitted within prescribed time.

There will be a written examination consisting two papers in two shifts to be held on the same day. The examination will be held as per Schedule given below:-

Second question paper will be descriptive. The answers shall be written by the candidates on answer sheets provided to them. The syllabus of 2^{nd} Paper shall be as under:-

- Note- (1) Current/leading cases shall be based on JOTI Journal of last **five** years.
 - (2) The Questions based on law pertaining to Gender Sensitization and sexual offences shall also be asked. Some question may be asked relating to basic procedural aspects of sexual offences and directions issued by Supreme Court of India or High Courts in various judicial pronouncements.
 - (3) Question relating to framing of charges or Judgment/order (Criminal) Writing may include, certain questions involving sexual offences.
 - (4) Judgment shall be either of Criminal Case or of a Civil Case and a candidate has to attempt from the stage of charges/issues onwards.
 - (5) Evaluation of Judgment will be divided as under-Charge/Issue-05 Marks.

Marshalling of evidence 05 Marks,

Appreciation of evidence and application of law – 15 Marks

Findings and conclusion -05 Marks.

- (6) Order shall be either of Criminal Case or of a Civil Case, to be written.
- (7) For Settlement of issues/framing of charge, the matter shall be different from matter given for Judgment writing.
- (8) It is also made clear to the candidates that the quoting

of principle/ratio of any citation/Judicial pronouncement is enough to write and quoting of particulars of citation will not carry any extra weightage but the quoting of wrong citation may be detrimental to the candidate.

6. Objections & Finalization of Model Answers of 1st Q.P.:-

After completion of examination, the proposed model answers/Keys intended to be used for preparation of result of 1st question paper (MCQ type), shall be uploaded/published on the website of the High Court of Madhya Pradesh for the purpose that if any candidate wishes to make any objection regarding any proposed answer, he /she may submit objection(s) in writing by mentioning his/her name, duly signed along-with self attested photo copies of source document(s)/ proof, on the basis of which he/she has raised objection, to the Principal Registrar (Exam) High Court of Madhya Pradesh, Jabalpur, through E-mail (pregexamhcjbp@mp.gov.in) within 03 days from the date of uploading/ publication of the proposed model answer key.

Objection(s) received in aforesaid manner and within prescribed time limit along with self-attested copies of the source/proof document will be taken in consideration. Result will be generated after finalization of objections. If no objection is received within prescribed time then proposed answers shall be treated as final for purpose of valuation and generation of result.

After declaration of result, no representation/ objection regarding model answers / questions, shall be entertained on any ground(s) and shall stand rejected without assigning any reason.

7. Bench Mark: -

There shall be 100 marks for "bench mark" performance of the Officer, to be evaluated on following criteria which shall form part of the final result –

- Notes- 1. Every candidate/ Judicial officer appearing in this examination is required to submit one contested Civil judgment and one contested criminal case judgment passed by him within five years preceding to the date of advertisement. The judgments of only those candidates will be evaluated/scrutinized who have secured atleast 50% marks in aggregate of both 1st& 2nd question paper.
 - 2. For computing marks of ACR's and Disposal of last five years, the following parameters shall be adopted.
 - (i) For each year ACR Grade-wise mark shall be as under :-

- 3. In computing of disposal marks of last five years, the period when no judicial work was assigned, shall be excluded.
- 4. The criterion for calculating disposal marks shall be subject to such notification(s)/orders etc. issued by High Court of Madhya Pradesh from time to time regarding average unit required for a period of time.
- 5. If the concerned officer is on deputation, the period shall be taken into account only where judicial work is being done by him for calculating disposal marks.
- 6. To consider reputation and integrity, vigilance report of concern judicial officers shall be called from Vigilance Cell.

- 7. Notwithstanding that a person has passed such Limited Competitive Examination, the promotion will be considered by the High Court of Madhya Pradesh on the basis of his previous performance and reputation.
- 8. Merely passing Limited Competitive Examination does not create any right to promotion unless previous performance and reputation has not been considered fit and proper for such promotion by High Court of Madhya Pradesh.

8. Result /Final Select List :-

After completion of entire above-mentioned process of selection, the result shall be prepared as early as possible and published on the website of the High Court of Madhya Pradesh. A Candidate/Civil Judge, aspirant for promotion under Rule 5(1)(b) shall have to secure minimum 50% marks separately in Benchmark performance apart from Minimum 50% marks in aggregate of 1st and 2nd Paper to qualify. Final selection will be subject to number of posts and merit of the candidate.

There is no provision for revaluation of answer-books / answer sheets or Benchmark performance and if any application is received from any candidate in this regard the same shall be rejected.

9. Corrigendum: -

At any time after the recruitment process has started, if any Clarification, Modification etc. is required to be made on the part of High Court of Madhya Pradesh then it may be done by porting a corrigendum, on the official website of High Court of Madhya Pradesh. Porting of corrigendum on official website shall be deemed as sufficient notice to all candidates/ aspirants and no objection shall be entertained on the ground that candidate was having no information of such corrigendum.

10. R.T.I. -

If any candidate applies under RTI and if rules permit then the desired information shall be made available, only to the concerned candidate by the

High Court of Madhya Pradesh, subject to payment of prescribed fees that too only after declaration of Final Result and before expiry of period of elimination of records.

11. Elimination/disposal of Used Examination Materials :-

All the used Examination Material shall be eliminated after expiry of One Year from the date of Declaration of Final Result.
