Finalized Model Answers shall be used as Keys/model Answers for the generation of result/valuation of OMR sheets of 1st Question Paper.

After declaration of result, no representation regarding any objection/clarification of any Model Answer/Question(s), shall be entertained on any ground, whatsoever and the representations received after declaration of the result, shall stand rejected without assigning any reason."
