Objections/clarification received in aforesaid manner and within prescribed time limit along with self-attested copies of the source/proof document will be taken in consideration. **However**, any objection received without any authentic proof/ source or after aforesaid stipulated period/time shall not be considered on any ground whatsoever it may be, and **shall stand rejected without assigning any reason**.

After consideration on objection(s), if any, the Model Answer shall be finalized and used as Keys/model Answer for the generation of result/valuation of the OMR Answer sheets of the First Questions Paper (Objective Type) of above mentioned test.

If no objection is received regarding proposed Model Answer Keys then proposed Model Answer Keys, may be treated as final Model Answers, and generate the result on the basis of proposed Model Answer Keys.

After declaration of result, no representation regarding final model Answer/questions, shall be entertained on any ground, whatsoever and stand rejected without assigning any reason.


