After consideration on objection(s), if any, the Model Answer shall be finalized and used as Keys/model Answer for the generation of result/valuation of the OMR Answer sheets of the First Questions Paper (Objective Type) of above mentioned test.

If no objection is received regarding proposed Model Answer Keys then proposed Model Answer Keys, may be treated as final Model Answers, and generate the result on the basis of proposed Model Answer Keys.

After declaration of result, no representation regarding final model Answer/questions, shall be entertained on any ground, whatsoever and stand rejected without assigning any reason.
