High Court, Jabalpur, within 07 days from the date of uploading/publication of the proposed Model Answers/Keys, during working hours (10:00am to 5:00pm), mentioning his/her Name & Roll No., along with self attested photocopies of source document(s)/proof, on the basis of which he/she has submitted the objection/clarification.

However, any objection/ clarification received without any authentic proof/source or any objection received after aforesaid stipulated period/time shall not be entertained/considered on any ground whatsoever it may be and shall stand rejected without assigning any reason.

Objections/clarification received in aforesaid manner and mode within aforesaid time limit along with self attested copies of the source/proof document shall be considered and the model answers shall be finalized by the committee, after taking into consideration objection(s)/clarification(s), if any, received from any candidate(s). The finalized Model Answers shall be used as Keys/model Answer for the generation of result/valuation of the OMR Answer-Sheets of candidates.

After declaration of result, no representation regarding any objection/clarification of any Model Answer/Questions, shall be entertained on any ground whatsoever it may be and such representations received, if any, after declaration of the result, shall stand rejected without assigning any reason."
