
In continuation of earlier notification No. 06/Exam/CJ/2019(Phase-II) dt. 09.02.2021, in order to provide prior information to candidates regarding State in which their examination center may be allotted, List of States (where no test centers are proposed) merged with States, where Test Centers will be allotted, is provided with a further facility that candidate(s) may check his/her examination State by login the application form with their credentials (provided earlier on registered e-mail ID & mobile number) and in case if he/she want to change State preference from one State to another, (Subject to availability of nodes) then he/she may do so by capturing State of preference from the given state drop down list in tab provided for the above purpose. It is made clear that this facility shall be available for limited time i.e. dt. 25.02.2021 (11.00 am) to 28.02.2021 (6.00 pm).

It is clarified that if any candidate does not avail the facility than it shall be presumed that he/she is satisfied with State allotted to him by the Service Provider and after lapse of above period, no request regarding change of State shall be entertained.

It is further clarified that after above mentioned exercise City/Test Center in particular State to concern candidate will be allotted by Service Provider as per availability of Nodes which shall be final and shall be displayed at the time of issuing admit cards. e
