Applications are invited for One Time Suitability Test-2019 of 10 vacant post of Court Manager in District Courts, in the pay scale of ₹ 15600-39100 + 5400/- Grade Pay (As amended time to time).

1. Eligibility:-

Only who are serving or have served as Court Manager for more than 05 years on contractual basis in District Courts & High Court of State of Madhya Pradesh, are eligible under Rule 18 (4-a) of Madhya Pradesh District Court Establishment (Recruitment and Conditions of Service) Rules, 2016.

2. Application:

All eligible candidates (as per list attached) who are desirous of appearing in the One Time Suitability Test are directed to send duly filled Application Form alongwith self attested copies of documents, two coloured passport size photo on or before <u>18-10-2019</u>.

The proforma of the Application Form is attached with advertisement.

- Notes:- 1. Candidates are required to fill all necessary information carefully before submission of Application Form, there shall be no provision for correction after submission.
 - 2. Candidates are advised to keep with him/her a copy of the finally submitted application/form.

3. Examination Fee :-

No fee shall be charged to the eligible candidates for appearing in the written test of One Time Suitability Test-2019.



4. Age Limit :-

As per Rule 7(e-1) of the Madhya Pradesh District Court Establishment (Recruitment and Conditions of Service) Rules, 2016 candidate who had been appointed on contractual basis in High Court / District Court of M.P. and has worked for 5 years or more, shall be entitled for age relaxation of the period of contractual appointment, subject to maximum age limit up to 55 years.

5. Post Selection Process :-

- (i) A candidate selected for appointment shall be required to undergo medical examination by a Medical Board before he/she is appointed. Every candidate who appears before a Medical Board shall pay the Medical Examination fee, which in no case shall be refundable.
- (ii) The training shall be such as may be prescribed by the High Court.
- (iii) A person appointed as Court Manager shall be on probation for a period of two years and the High Court may extend the period of probation. The High Court may, at any time during or at the end of period of probation, recommend the termination of services of such probationers.
- (iv) The conditions of service of appointment on the post advertised shall be governed by the Rules, Regulations and Circulars *etc.* applicable to the Madhya Pradesh District Court Establishment (Recruitment and Conditions of Service) Rules, 2016, in force from time to time.

6. <u>Duties and responsibilities of court manager-</u>

All the Court Managers will have to perform duties & take up responsibilities fixed by SCMS Committee of High Court of M.P. Jabalpur as per Endorsement No. B/4661/III-19-21/57(SCMS), Jabalpur dt. 13th September, 2019.

7. Call Letters:-

Admit Cards/Hall Tickets shall be generated by MP High Court on its website (www.mphc.gov.in) and the candidate shall download and may take a print-out of Admit Card. It shall be ensured that Admit Cards are generated by MP High Court atleast 10 days prior to the date of Examination.

Admit Cards/hall Tickets will be issued only to those candidates, who have submitted his/her application forms complete in all respect within prescribed period. If any candidate fails to submit application form within prescribed period, it shall tantamount to their non- willingness to appear in one time suitability test, 2019.

8. Selection Process –

Selection process shall be conducted in three phases i.e. (1) Written Examination (2) Past performance appraisal (3) Interview.



9. Written Examination –

There shall be a written examination (objective type) containing 100 multiple choice questions (of 50 marks) whose answer has to be given in 02 hours on OMR sheet provided by the examination cell. Date, time & venue of the written test shall be notified later by publishing a notification on the website of M.P. High Court.

(A) Syllabus & Pattern of Question Papers -

There shall be objective type question of 50 marks. The Subjects/ syllabus of one time suitability examination shall be as under: -

(B) Objections & Finalization of Model Answers -

After completion of written examination, the proposed Model Answers/Keys intended to be used for result shall be uploaded/published on the website of the M.P. High Court with the Notice to the effect that if any candidate wishes to make any objection/clarification etc. regarding any Model Answer/Key, he /she may submit objection/clarification in writing & signed by him to the Principal Registrar (Exam)/ Registrar (Exam) M.P. High Court, Jabalpur, within 7 days from the date of uploading/ publication of the proposed Model Answers/ Keys, by mentioning his /her Name along with self attested photo copies of source document(s)/ proof, which is/are base of his objection/clarification raised.

Objections/clarification received in aforesaid manner and mode within aforesaid time limit along with self-attested copies of the source/proof document shall be considered and the model Answers shall be finalized. After declaration of result, no representation regarding any objection/clarification of any model Answers/questions, shall be entertained on any ground and shall be rejected without assigning any reason.

10. Past performance -

Candidates who are serving/have served for more than 05 years as Court Manager on contractual basis in District Courts/High Court, their past 05 years appraisal report shall be taken into consideration and marks will be awarded of each year performance, the same shall be of 25 marks, marks of the past appraisal shall be added in the preparation of final result & score card of the concerned candidates.

11. <u>Interview</u> –

Interview shall be held simultaneously on the date of Written Exam, which shall be of 25 marks.

12. Passing Marks-

For the appointment of Court Manager through one time suitability test, candidates have to secure 55% marks in the one time suitability test.

13. Final Result -

The Result shall be ported on the Website and shall also be affixed on the Notice Board of M.P. High Court. Marks List of the candidates may also be ported on the Website of M.P. High Court (www.mphc.gov.in).

14. District Allocation-

All selected candidates have to fill 5 districts of their choice in Application Form. As per availability of District place, selected candidates shall be posted on district place of their choice but in no circumstances any candidate will have a right to claim posting at any desired place.

15. Travelling Expenses –

No Travelling Expenses or allowances will be payable to any candidate for appearing in the written test of One Time Suitability Test-2019.



16. Elimination/disposal of Used Examination Material -

After lapse of one year from the date of declaration of final result, all the records of this examination including application forms etc. of candidates shall be eliminated.

17. Right to Information -

Answer sheets of Examination shall be provided by Examination Cell as per direction of Registrar (S.P.I.O.) after the declaration of final result. For applying under R.T.I. candidates have to apply online, the link is available on the website of M.P. High Court.
