# APPOINTMENT FOR THE <u>ONE</u> POST OF "SENIOR COMPUTER PROGRAMMER" IN MADHYA PRADESH STATE LEGAL SERVICES AUTHORITY, JABALPUR

Applications are invited from Indian Citizens for the Un-reserved post of Senior Computer Programmer, by direct recruitment, who fulfill the following qualifications and eligibility conditions as on the date of advertisement.

01.	Senior Computer Programmer	6500 – 10500 & As per 7 <sup>th</sup> Pay Scale (42700 – 135100)	01	Must be a Graduate from any recognized University. or Must possess BCA degree from a recognized university. Candidate should have good knowledge of computer.

#### Maximum Age Limit: -

- (a) Must not be below 18 years and above 35 years of age as on 1<sup>st</sup> day of January, 2018.
- (b) Provided that the upper age limit shall be relaxable upto a maximum of three year, if the candidate belongs to Schedule Casts, Scheduled Tribes or other Backward Classes.
- (c) Provided further that the upper age limit shall be relaxable upto a maximum of 10 years in respect of a woman candidate in accordance with the provisions of the Madhya Pradesh Civil Services (Special Provisions for Appointment of Women) Rules, 1997.
- (d) Provided further that the upper age limit shall be relaxable upto 05 years in respect of the widow, destitute or divorced woman candidates.
- (e) Provided also that the upper age limit of a candidate who is a Government Servant (whether permanent or temporary) shall be relaxable upto the age of 38 years.

#### Disqualification:-

- (a) No male candidate who has more than one wife living and no female candidate who has married a person having already a wife living, shall be eligible for appointment to any post.
- (b) No candidate shall be appointed to a post unless he has produced the Medical Certificate from the Chief Medical and Health Officer in the prescribed form of his being in good Mental and Physical Health and free from any Physical defect likely to interfere with the efficient discharge of his or her duty.
- (c) A person dismissed by the Central or State Government or by Officer of the Central or State Government or by a Local Authority or Corporation, owned or controlled by the Central or State Government, shall not be eligible for appointment.

(d) No candidate shall be eligible for appointment to any of the posts if, after such enquiry as may be considered necessary, the appointing authority is satisfied

- that he/she is not suitable in any respect for appointment to any of the posts.
- (e) No candidate shall be eligible for appointment to the Post, who has married before the minimum age fixed for marriage.
- (f) No candidate shall be eligible for appointment to the Post, who has more than two living children, one of whom is born or after 26<sup>th</sup> January, 2001.

#### Examination Fees:-

For the same post Fee Rs.100/- for all categories candidates by online "Cyber Treasury" or directly in Treasury in the Head of Accounts (0070-Other Administrative Services, 01-Administration, 800-Other Receipts) & also attached original receipts of payment alongwith their Application Form/Resume.

#### Condition of Service:-

In respect of all such matters regarding conditions of service of the Officers and Employees of the Madhya Pradesh State Legal Services Authority for which there is no provision or the provisions are insufficient in these rules, the rules and orders for the time being in force applicable to the Government Employees holding corresponding posts, in the State Government, shall be applicable.

#### General Information: -

Eligible persons who fulfill the prescribed qualification, experience, age requirement and other eligibility criteria as on 01.01.2018 may send their Application Form/Resume alongwith self attested copies of all necessary documents, two coloured passport size photo to the office of the Principal Registrar (Exams), Administrative Block, High Court of M.P., Jabalpur by mentioning on the Top of the envelop "Application for the post of Senior Computer Programmer (M.P.S.L.S.A.)" on or before \$\frac{92}{08}/2018 (Tue\sqrt{a})\$ the Examination Cell will not be responsible for any postal/courier loss or delay.

The Application Form/Resume and documents so received in the examination cell shall be scrutinized by the staff and thereafter, the list will be prepared in the ratio of 1:5, on the basis of relevant qualification and experience. Then, the same eligible candidates will have to appear for an Interview before a Board to be constituted by Hon'ble the Chief Justice of the High Court.

The eligible candidate list for an Interview should be ported on the website of High Court M.P. i.e. <a href="www.mphc.gov.in">www.mphc.gov.in</a>.

Candidates who do not fulfill the prescribed qualifications and other eligibility conditions need not apply. If apply their application form/resume summarily filed without given any reason.

No TA/DA will be paid to the candidates for appearing in the interview. Candidates already in service should apply through proper channel only.

The candidate selected will be appointed initially on probation for a period of two years. The said appointment will not confer upon him/her any right or title to claim appointment on the cadre post or promotion in the regular channel.
