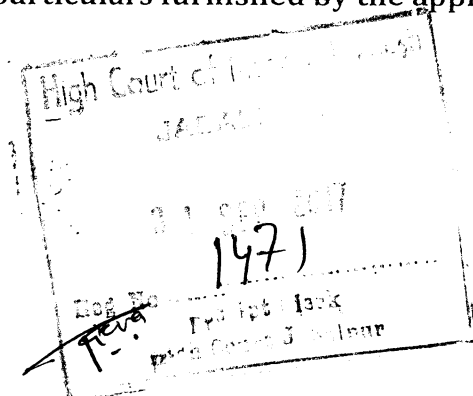

It is proposed to fill up one post of Registrar in the Pay Band-4(₹37,400 – 67,000) plus Grade pay of ₹10,000/-, (Level-14 of pay matrix), General Central Service, Group'A' Gazetted, Non-Ministerial in National Consumer Disputes Redressal Commission (NCDRC), Delhi under the administrative control of the Department of Consumer Affairs in the Ministry of Consumer Affairs, Food and Public Distribution. The post is proposed to be filled up by composite method [Deputation (Including Short Term Contract)/ Promotion] from the officers under the Central Government or State Government or Supreme Court or any High Court or PSUs or Tribunal or any Quasi- Judicial Authority:-

(A)(I) Holding analogous posts on regular basis in the parent cadre or Department; or

(II) with two years' service in the grade rendered after appointment thereto on regular basis in the Pay Band-4 (₹37,000-67,000) plus Grade Pay of ₹8,900/- or equivalent in the parent cadre or Department; or

(III) with three years' service in the grade rendered after appointment thereto on regular basis in the Pay Band-4 (₹37,000-67,000) plus Grade Pay of ₹8,700/- or equivalent in the parent cadre or Department; and

(B) Possessing the following Educational Qualification and Experience:-

(I) A Degree in Law from a recognized University, and

(II) 15-years' work experience in Group-A posts:-

(a) in a Court or Tribunal or Quasi-judicial Authority; or

(b) experience in Personnel and Administrative matters and interpretation of rules, regulations, instructions issued by the Government from time to time.


