Note:-

1. **Part heard/specially assigned matters (excluding reserved for Judgment/ Orders) shall cease to be part heard/specially assigned with change of assignment, unless a written request for continuation of the matter before the same Bench is made by the parties and is approved by Hon'ble the Chief Justice.**
2. Admission and 'for orders' Matters pertaining to Division Bench not assigned to DB-I, will be listed before D.B.-II.
3. All matters which are ordered to be connected/linked will be listed as one item/serial number before the Hon'ble Senior most Division Bench; and in case of Single Bench matters, before the Hon'ble Senior most Single Bench, **to whom such Civil or Criminal Cases are substantially assigned.**
4. (a) Mentioning of all (D.B. / S.B.) matters not notified in the Daily / Weekly List be made before the **Division Bench-I**, except matters assigned to D.B.-II (only for VYAPAM Matters). However, mentioning of matters

already notified in the Daily / Weekly List shall be made before the concerned Hon'ble Division Bench / Single Bench, where the matter is so listed.

- (b) Mentioning of **SB Arbitration matters, Company matters and Tax matters**, be made before **Hon'ble Shri Justice S.K. Gangele** and mentioning of **SB Election matters** be made before **Hon'ble Shri Justice Chandrahas Sirpurkar**.
 - (c) **Mentioning of all (D.B./S.B.) pre-admission matters in respect of which Computer generated date has been authenticated by the Registrar (Judicial) be made before DB- I, except matters assigned to D.B.-II (only for VYAPAM Matters) only if the party is not satisfied with the date so assigned or for pre-ponement or postponement of that date.**
 - (d) **Mentioning for listing of interim application filed in the main matter for urgent relief before the date assigned for the main matter also be made before DB-I, except matters assigned to D.B.-II (only for VYAPAM Matters).**
 - (e) **The Computer generated date authenticated by the Registrar (Judicial) of pre-admission matters, henceforth, is treated as Court given date and the matter will be listed on that date before the concerned Bench as per the assignment, without any exception. There is no need to mention these cases before the Court.**
5. The Weekly List will consist of matters taken from the Consolidated/ Quarterly List category-wise distributed amongst the concerned Benches in proportionate lots chronologically.
 6. **Under the listing scheme, all pre-admission cases have been assigned specific computer generated / court order dates. Therefore, filing of urgent hearing applications in these cases is avoidable.**
 7. **The Advocates and parties may mention any matter ready for final hearing and is left out from the current weekly list, which is older than the oldest of same category of cases listed in the weekly list, before the Registrar (Judicial-II) from 10.30 a.m. to 11.30 a.m. on any working day for inclusion in the quarterly list so that it can find place in the following week as per its turn.**
 8. **If any Final Hearing case fits in two or more categories of priority category, then direction can be given by the Registrar (Judicial-II) to include it in the category where it would get priority, if not properly positioned in the list already notified by the Registry.**
 9. All Division Bench(s) Review Petitions pertaining to cases not assigned to DB-I, where both the Hon'ble Judges are not available due to change of Headquarter, transfer, elevation or retirement will be listed before Hon'ble DB-II.
 10. **Repeat Bail Applications filed under Section 389, 438 and 439 of the Cr.P.C. shall be listed before the Hon'ble Judge who decided the first application. However, if the Hon'ble Judge, who decided the first application, is not available due to change of Roster, Headquarter, transfer, elevation or retirement, then the subsequent bail applications shall be listed before the senior most (D.B. / S.B.) Bench to whom substantial Criminal Cases are assigned.**
 11. All bail applications under section 438 & 439 Cr.P.C. arising from the same crime number of the same Police Station and application for suspension of sentence under section 389 Cr.P.C. arising from the same judgment filed by the different applicants separately shall be connected / linked along with the first such application to be included in the daily list and will be listed before the same Hon'ble Judges(s), irrespective of the date of their institution by different co-applicants. **However, if the same Hon'ble Judges(s) is/are not available, the subsequent fresh bail application of co-accused persons will be listed before available senior most Hon'ble Judge(s) to whom substantial Criminal Cases are assigned.**
 12. The fresh for admission left over matters which could not reach or taken up due to non-availability of concerned Bench on the given day will be listed in the

following week. However, after notice / Final disposal matters which could not reach or taken up for hearing due to non-availability of the concerned Bench will be deferred in suitable lots to be notified by the Registry as per the availability of slot in the CMIS listing scheme.
